Does DUI and DWI mean the same in New York law?

In New York, drunk driving offenses are usually classified into DWI, which can be a misdemeanor or felony, and DWAI, a violation, as per Vehicle and Traffic Law 1192. Although similar offenses are termed DUI in other states, in New York, these offenses are referred to as DWI or DWAI.

What does 'Hardship Privilege' signify in the context of DWI charges?

The 'Hardship Privilege' refers to a provision in New York law that allows a person charged with DWI, and whose license has been suspended, to apply for limited driving privileges, particularly when no other transportation means to work are available. However, certain eligibility requirements must be met to avail of this privilege.

How are DWI and DWAI offenses categorized in New York?

In New York, DWI is generally a misdemeanor, while DWAI is a traffic infraction. However, specific situations can escalate a DWI to a felony and a DWAI to a misdemeanor, such as if there's a previous DWI conviction within the last ten years or if an underage passenger was present in the vehicle.
