

Privacy Policy for Mood Journal

Mood Journal ("we", "our", "us") values your privacy. This Privacy Policy outlines how we collect, use, and protect your personal information when you use our mobile application ("Mood Journal" or the "App"). By using the Mood Journal app, you agree to the collection and use of information in accordance with this policy.

1. Information We Collect

We collect the following types of information to provide and improve our services:

a. Personal Information:

When you use the App, we may collect personal information such as your name, email address (if provided for support or communication), and any other information you voluntarily provide when logging your moods and adding notes.

b. Mood and Activity Data:

We collect mood data, including the mood emojis you select and the notes you add to each entry. This information is stored to help you track and reflect on your emotional state over time.

c. Device and Usage Information:

We collect data about your device (e.g., device type, OS version, and IP address) and how you interact with the App, including crash reports, analytics data, and usage patterns.

2. How We Use Your Information

We use the information we collect for the following purposes:

- To provide, maintain, and improve the functionality of the App.
- To analyze trends and user behavior to enhance your experience.
- To respond to support requests or communication.
- To provide personalized insights into your mood history and emotional trends.

3. Data Storage and Security

Your mood entries and any personal information you provide are stored securely. We use standard encryption methods to protect your data during transmission. While we take reasonable steps to protect your personal information, no method of electronic storage or transmission is 100% secure.

4. Sharing Your Information

We do not sell, rent, or share your personal information with third parties. However, we may share your information in the following cases:

- To comply with legal obligations, such as a subpoena or court order.
- To protect our rights, property, and the safety of users.

5. Third-Party Services

The App may use third-party services (e.g., analytics, crash reporting). These third parties may have access to your information to perform specific tasks on our behalf, but they are obligated not to disclose or use it for any other purposes. Examples include Firebase for app analytics and Google Play Services for app functionality.

6. Your Data Rights

Depending on your location and applicable laws, you may have rights to access, update, or delete your personal information. If you would like to make a request or have any concerns about your data, please contact us at the contact information provided below.

7. Children's Privacy

Mood Journal is not intended for children under the age of 13. We do not knowingly collect or solicit personal information from children under 13. If we discover that we have collected personal information from a child under 13, we will take steps to delete such information.
