Privacy Policy for Pixoraft

At Pixoraft, your privacy is important to us. This Privacy Policy explains how we collect, use, and protect your personal information when you use our text-to-image generation app.

1. Information We Collect

When you use Pixoraft, we collect the following information:

- **Google Login Information**: When you sign in using Google, we collect and store your Gmail address for authentication purposes only.
 - We do not share, sell, or disclose your email address to third parties.
- App Activity and Performance Data: We may collect non-personal data related to your usage of the app, including:
 - o Crash logs and diagnostics.
 - App interactions and performance data to improve functionality and resolve issues.
 - These logs are stored temporarily for diagnostic purposes and are not shared with third parties.

2. How We Use Your Information

We use your Gmail address to:

- Identify and authenticate you as a user.
- Provide a personalized experience.
- We do not use your data for advertising or marketing purposes.

3. User Content and Prompt Handling

- You can enter a text prompt in the edit box to generate images.
- Prompts and generated images are checked using safety filters to block content related to:
 - Violence
 - Sexual content
 - Hate speech
- Any prompt violating these rules will be blocked to maintain a safe and respectful environment.

4. Reporting Mechanism

- Each generated image includes a report button.
- If a user finds content inappropriate, they can report it.

Reports submitted via the "Report" button are stored for review by our team to
ensure compliance with our content guidelines. These reports may include details
such as the generated image, user prompt, and the reason for the report.

5. User Controls

In the Profile section, users have two options:

- Logout: Immediately logs you out of your Pixoraft account.
- Delete Account:
 - You will receive a warning:
 "Are you sure you want to delete your account? All data related to your account will be permanently deleted from Pixoraft."
 - If confirmed, your account and all associated data will be permanently deleted from our servers, except where required by law or for the purpose of reporting inappropriate content (e.g., safety and compliance).
 - You can always rejoin the Pixoraft community by signing up again.

6. Data Security

We use HTTPS encryption to protect your personal data during transmission and secure storage practices to safeguard your data. However, no method of transmission over the Internet or electronic storage is 100% secure.

7. Data Retention

We retain your data only for as long as necessary to provide our services, comply with legal obligations, resolve disputes, and enforce our agreements. Crash logs and other performance data may be retained for a limited period for diagnostic purposes.

8. Changes to This Privacy Policy

We may update this Privacy Policy from time to time. When we do, we will notify users within the app. Continued use of Pixoraft after changes implies your acceptance of the revised policy.
