

Annex 1. Non-mandatory proposed format for ETE

Below a **non-mandatory** format for the ETE partnership reports is proposed. Partners have the liberty to adjust or use a different format.

Proposed ETE format

1. Executive summary (3-4 pages – English)
2. Introduction (1-3 pages)
 - Background of the partnership programme
 - Objectives of the ETE
3. Methodology (3-5 pages)
 - Methodology and approach
 - Bias and limitations including a discussion of the consequences of these biases and limitations on the research findings
4. Programmatic focus of the partnership programme (overall) (approx. 25 pages)
 - 4.1 Description of context (multiple countries/overall context with regards to civil society and relevant themes)
 - 4.2 Theory of Change
 - Including an assessment of the relevance of the ToC and the validity of assumptions underlying the different segments of the ToC
 - And if relevant the adjustment made to the ToC due to changing contexts
 - 4.3 Effectiveness
 - Including a description of the activities of the programme and a mapping of (allotted) funding/budget(s)
 - Including achievements to date on the output and outcome indicators that are linked to the Strengthening Civil Society and thematic Result Framework basket indicators (disaggregated as per the SCS IATI indicator guidelines.)
 - Including unintended/unexpected effects
 - (Preferably also) Including achievements to date on the overall results framework of the programme
 - Including an assessment of the contribution of the partnerships towards achieved outcomes
 - 4.4 Crosscutting themes (gender, youth, climate)
 - 4.5 Sustainability
5. Partnership collaboration (overall) (approx. 10 pages)
 - 5.1 Coherence (within the partnership, between partnerships and MFA and with other stakeholders)
 - 5.2 Localisation/leading from the south
6. Information per country/region/international component (approx. 10 pages per country/region etc.)
 - 6.1 Country X
 - Description of context (in relation to civil society/civic space)
 - Theory of Change
 - Including an assessment of the relevance of the TOC and the validity of assumptions
 - And if relevant the adjustment made to the TOC due to changing contexts
 - Effectiveness
 - Including a description of the activities of the programme and a mapping of funding
 - Including achievements to date on the output and outcome indicators that are linked to the Strengthening Civil Society and thematic Result Framework basket indicators (disaggregated as per the SCS IATI indicator guidelines.)
 - Including achievements to date on the overall result framework of the programme

- Including an assessment of the contribution of the partnerships towards achieved outcomes
- Crosscutting themes (gender, youth, climate),
- Sustainability
- Coherence (within the partnership, between partnerships and MFA and with other stakeholders)
- Localisation/leading from the south

Frequency of measuring indicators

For the Strengthening Civil Society Indicators, the reporting frequency is as follows:

- Baseline, MTR and end evaluation: SCS1 – SCS2 – SCS3 – SCS4 – SCS9
- Annually: SCS5 – SCS6 – SCS7- SCS8

For Women's Rights and Gender Equality (WRGE) indicators, the reporting frequency is as follows

- Baseline, MTR and end evaluation: all outcome indicators (i.e. WRGE 1.1-1.3, WRGE 2.1-2.3, WRGE 3.1-3.3, WRGE 4.1-4.3)
- Annually: all output indicators (i.e. WRGE 5.1.2 and WRGE 5.2.2)

For SRHR indicators, the reporting frequency is as follows

- Baseline, MTR and end evaluation: all outcome indicators (1 up to 4)
- Annually: all output indicators (A up to K)

Results on thematic indicators which are linked to SCS indicators can be reported under the thematic (WRGE/ SRHR) indicators, no need to double report
