1. Introduction

You can opt out at any time by replying **STOP** to any message. After opting out, you will receive a confirmation message and then no further messages unless you re-subscribe.

We implement administrative, technical, and physical safeguards designed to protect your personal information from unauthorized access, disclosure, loss, or misuse.

7. Children's Privacy

Our services are not directed to children under the age of 13. We do not knowingly collect personal information from anyone under 13. If you believe we have collected such information, please contact us to have it removed.
