

# Privacy Policy

## What Type of Information do We Gather

Because Buenas allows you to add its outputs HauteCorner on your promotional material (Print advertisements, Websites, Online Ads, Packaging etc.), you must register for an account for the desired services. The registration process asks for your personal information such as but not limited to the:

- First Name, Last Name
- Email Address
- Password

By the nature of our Service, Buenas will gather non-personally identifiable statistics about the usage of our outputs in your promotions and store that information.

## How do we use this Information?

When you log into the Service, our servers automatically record the information that you enter in the app. These server logs may include information such as your web request, Internet Protocol address, browser type, browser language, the date and time of your request, browser user agent, and one or more cookies that may uniquely identify your browser.

When you send email or other communication to Buenas , we may retain those communications in order to process your inquiries, respond to your requests and improve our services.

Buenas will not share your personal information without your consent or unless required by law.

Buenas will not share your website/app statistics without your consent.

Buenas only processes your personal information for the purpose of providing, improving, ensuring the delivery of, and developing new services to users.

If Buenas becomes involved in a merger, acquisition, or any form of sale of some or all of its assets, we will provide notice before your personal information is transferred and becomes subject to a different privacy policy.

## How we protect your Personal Information

HauteCorner has implemented reasonable security mechanisms to protect HauteCorner Customer Information and Customer User Data that is maintained on HauteCorner servers from loss, misuse and unauthorized access, disclosure, alteration and destruction. Examples of these security mechanisms include limited and password-protected access, high security public/private keys, encryption on processed data, and SSL encryption to protect transmission of data.

This helps us gain an understanding of our visitors' Demographics and Interests. The reports are anonymous and cannot be associated with any individual personally identifiable information that you may have shared with us.
