- 1 Definition
- 1.1. Personal information: refers to various information recorded electronically or in other ways that can identify the personal identity of a natural person alone or in combination with other information, including but not limited to the name, date of birth, ID number, personal biometric information, and address of the natural person Wait.
- 1.2. Personally sensitive information: refers to personal information that, once leaked, illegally provided or abused, may endanger the safety of personal and property, and easily lead to personal reputation, physical and mental health damage, or discriminatory treatment. For example, personal sensitive information includes ID number, personal biometric information, bank account number, communication content, health and physiological information, etc. For the personal sensitive information listed in this privacy policy, in order to make it easier for you to be alert when reading, we will use bold fonts, underlined or separately pointed out to remind you to pay attention.
- 1.3. Equipment: A device used to access the service, such as a tablet or smart phone.
- 1.4. Unique device identifier (exclusive ID or UUID): refers to a string of characters compiled into the device by the device manufacturer, which can be used to uniquely identify the corresponding device (such as the IMEI number of a mobile phone).

2. How we collect and use your personal information

We will only collect and use your personal information for the following purposes described in this policy:

2.1. Help you register as a user

2.2. Display and push information for you
