The way to write sources in text needs to clearly show source citations, which include author's name, publication year, and page number where the text is located. Examples of reference writing are as follows: ...students should not only be content users but should become content creators and knowledge builders (Smaldino, Lowther, & Russell, 2011: 178). Another example: ... assessment for material experts has been adjusted according to Skaggs & Bodenhorn's opinion (2006: 82).

Direct quotations of more than 40 words are written as in the following example: ...multimedia used in learning, Philip (1997: 8) states that:

The introduction is written with Times New Roman -12 upright. Each paragraph begins with words indented 5-6 digits.

#### **METHODS**

Contains research type, time and place of research, target/subject, research subjects, procedures, instruments, data collection techniques, and data analysis techniques, as well as other matters related to the research method. Each of these matters is written narratively in paragraphs, without subheadings, with lowercase letters beginning with capital letters, *Times New Roman-12*.

## RESULTS AND DISCUSSION

This section consists of presenting research/thinking results along with their discussion. Research/thinking results can be presented in the form of images/graphs/diagrams, tables, and/or descriptive text. In this chapter, don't just narrate the contents of tables and figures. Analysis and interpretation of these results are needed before discussion.

Figures and tables are written in the center of the column. Captions for figures and tables are written in the center. For figure captions, write below the figure, while for table captions, write above the table, all initial words are written using capital letters except conjunctions. Line spacing within tables uses *single space*. Examples can be seen in Figure 1 and Table 1. If figures and tables are large (requiring width more than column width), they are placed at the top or bottom of the page. Examples can be seen in Figure 2 and Table 2.
