- DGS students will get an email when their form is approved (or denied).
- DGS students must purchase their dance ticket along with the guest ticket at the same time. Students must enter the name of the approved guest. The DGS student will not be able to purchase a ticket for a guest who is not approved.
- Tickets may be purchased on the 5-Star App from <u>Tuesday, February 13th Friday, February 23rd.</u>
- No guest tickets will be sold at the door. DGS students and guests will not be admitted to the dance without a
 photo ID. The guest photo ID must match the name of the approved guest.

Student and Guest Agreement – By signing this form on the reverse side, we agree to the following:

All DGS students and guests must have a photo ID to be admitted to the dance. DGS students who bring an approved guest must be with that guest at all times. All approved guests are expected to follow all the rules in the student handbook. We will demonstrate appropriate behavior and respect to peers and staff members at all times. We will show respect for self and others relative to the space and our actions. We will refrain from dancing that is sexually explicit or inappropriate. Guests who violate school rules and policies will not be approved to attend future activities. Students who bring a guest who violates the student code of conduct may also be subject to school consequences (including exclusion from graduation activities).

We understand that if we do not abide by these standards, we may be asked to leave without warning and without a refund.

<u>DGS Deans reserve the right to deny any current non-DGS student from attending a DGS activity. Former DGS students or District 99 graduates are not automatically entitled to attend DGS activities. There is no appeal process if the guest is denied entry.</u>
