We are looking for a full-time associate (ideally in the DC area) to work remotely starting in January 2020. The hiree will undertake communications and development work as well as provide general support for the organization and other staff.

RESPONSIBILITIES: The Associate will report to EPN Programs and Operations Manager, Sebastian Irby, and will work closely with EPN Executive Director and Communications Associate. Sebastian is located in Washington, D.C. Work will be remotely located as EPN does not have an office.

- Communications specific work:
 - Update and maintain database of communications and development accomplishments
 - Draft weekly e-newsletter & assist with drafting and sending out the bi-monthly newsletter
 - Update website “In the News” section
 - Other website assistance
- Development specific work:
 - Update and maintain a database of foundations, individual donors, and donations
 - Draft and print (or email) thank you notes for signature
 - Assist with development committee meetings and activities, such as sending the bi-monthly newsletter to funders and potential funders
 - Assist with #GivingTuesday and other fundraisers and events
- Schedule meetings
- Other tasks to support EPN’s communications and development teams

QUALIFICATIONS:
