PUBLIC HEARINGS

• A Public Hearing led by Chief Financial Officer Rebecca Kelley was held to discuss BISD's rating in the state's



School FIRST (Financial Integrity Rating System of Texas) accountability system. BISD again received a **SUPERIOR** rating - for the nineteenth consecutive year! FIRST included five new indicators with a total of 20 financial indicators including administrative cost expenditures, the accuracy of a district's financial information submitted to TEA, compliance with payment terms of current debt obligations, long term debt ratio and other solvency related indicators, and any financial vulnerabilities or material weaknesses in internal controls as determined by an external auditor.

As well as bleachers for Brazosport H.S. Flash Walker Gym and Aux Gym, Furnishings for the District Technology Center, and the Hopper Field Stadium Lighting System were approved.

The Board of Trustees also approved the submission of the Low Attendance Day Waiver to TEA for December 2 and 3, 2021, for Lake Jackson Intermediate School.

ACTION ITEMS

- The Board approved the audit report presented by Wade Whitlow, CPA, of Kennemer, Masters and Lunsford. Mr. Whitlow shared that BISD's Business Office is a model of excellence for other districts. Brazosport Independent School District Annual Financial Report for the year Ending August 31, 2021.
- As presented by Kristi Kirschner, Chief Human Resources Officer, the Board of Trustees executed the Board Resolution to Discontinue Participation with TRS-ActiveCare effective September 1, 2022; they authorized the Superintendent or designee to submit notification to TRS to discontinue participation in TRS ActiveCare, and they authorize the Superintendent or designee to select FBS as Broker and Consultant to administer employee healthcare plans with Texas Schools Health Benefits Program. With Senate Bill 1444, school districts are now able to leave TRS for other insurance providers. HR conducted an extensive review of insurance possibilities as well as surveying BISD staff for direction and input. The board approved that TRS will no longer be our health insurance carrier beginning

September 1, 2022 and our new provider will be Texas School Health Benefits Program (TSHBP), whose board of directors include district leaders from across the state. Instead of rushing in August to make insurance decisions, staff will meet with representatives from TSHBP in the spring to allow time for us to carefully select the plan that is right for our families. Two of the plans are referred to as



Aetna Signature Plans which are on the Aetna network and closely compare to the plans available with TRS ActiveCare. One drastic difference is that the Aetna Signature plans do not require a named Primary Care Physician or require referrals for specialists.

The last two plans are managed care plans that offer both High Deductible and Copay plan options. Again, more choices for each of us!

- The Board held a Public Hearing on December 7, where Chief Financial Officer Rebecca Kelley and presented the districts possible plans for the <u>Redistricting Single Member Districts</u>, which is required after each 10 year Census. Ms. Kelley presented to the Board of Trustees at this meeting that they consider adopting the resolutions overview of the redistricting process and the proposed map "Plan 5" compared to the current map boundaries, and that the Board President and Secretary be authorized to execute the resolutions and other documents necessary to implement the plan of redistricting. The Board approved the action and they adopted a Resolution and Order for Single Member Board Redistricting.

• Chief Financial Officer Rebecca Kelley presented to the Board a possible option to purchase land in Jones Creek to build the new school that has been put on hold due to the most recent Flood Plains designations. Administration has worked with Jones Creek Officials and have identified a piece of property that would be outside of the floodplain elevation of the current campus. The Board authorized the Chief Financial Officer to negotiate final terms and enter an agreement with Campbell Gardner to purchase BCADID 150479, 4.69 acres - the subject property pursuant to the terms discussed in closed session and further authorize the Chief Financial Officer to conduct reasonable and necessary due diligence related to the property and enter other agreements necessary to finalize the transaction.

Administrative Considerations

- The District has collaborated with Jones Creek Officials to identify possible areas that are 17-20 are for the construction of the new S.F. Austin Elementary.
- Administration has identified a potential site off of Highway 36, between Weldon Road and Smith Road.





 Again, Chief Financial Officer Rebecca Kelley presented to the Board a possible option to purchase land in Jones Creek adjacent to the land purchase just approved by the Board. The Board authorized the Chief Financial Officer to negotiate final terms and enter an agreement with Donna Moore to purchase BCAD ID 597616, 13.981 acres - the subject property pursuant to the terms discussed in closed session and further authorize the Chief Financial Officer to conduct reasonable and necessary due diligence related to the property and enter other agreements necessary to finalize the transaction.

REPORTS

• 2021-2022 District Improvement Plan 1st Quarter Review - Assistant Superintendent Ron. Redden presented the 1st Quarter Review of the District Improvement Plan (DIP). The DIP, required under Chapter 11 of the Texas Education Code, is a comprehensive plan to improve the district in each of the five areas covered by our district goals. The 2021-2022 plan has a total of 13 Performance Objectives and 70 strategies to support the district's five goals. The Board adopted House Bill 3 goals for

early childhood literacy, early numeracy and College, Career and Military Readiness.

Performance Objectives that support District Goal 1 also addresses improving early literacy and numeracy skills, closing learning gaps, increasing college, career and military readiness and the continued implementation of the Curriculum Audit recommendations. Goal 2 Performance Objectives address the health, safety and social, emotional and mental health needs of students. The Performance Objectives that support Goal 3 addresses improving customer service across the district. Goal 4 Performance Objectives address improving the technology infrastructure and using supplemental funding to support special programs, the overall instructional program and efforts to close learning gaps. Performance Objectives for Goal 5 address staff recruitment, support, development and retention.

- There are 22 strategies that support the five Performance Objectives under District Goal 1.
- There are 18 strategies that support the two Performance Objectives under District Goal 2.
- There are three strategies that support the one Performance Objective under District Goal 3.
- o District Goal 4 is really a two-part goal. The first part of the Goal states that Brazosport ISD will exercise fiscal responsibility to ensure financial strength, and the second part that the district will provide resources to equip and maintain quality facilities and educational programming.
- There are ten strategies that support the three Performance Objectives under District Goal 5.

The district is on target to meet and exceed the Performance Objectives set in the 5 District Goals.



- Coordinating work with other campuses, or throughout the district, in order to meet a customer's needs (24% of respondents)






- Alec Journeay, Director of Planning and Construction, presented updates on the current progress of the 2014 Bond and 2019 Bond Programs.


