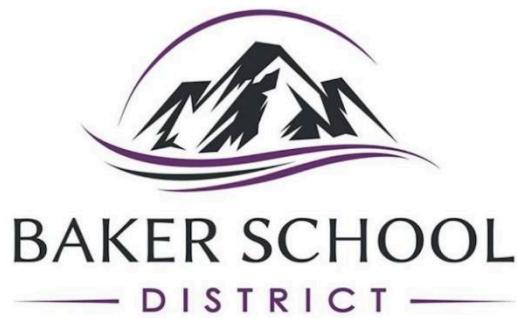

## SECTION 1. Clarifying Roles and Responsibilities

Identifying roles central to communicable disease management. Clarifying responsibilities related to communicable disease response is a first step in keeping communities healthy and safe. In general, decisions of school health and safety reside with school and district officials. Together with local public health officials, school/district administrators should consult a variety of individuals when making decisions about health and safety in school.

## Section 2. Equity and Continuity of Education

### Preparing a plan that centers equity and supports mental health

Preparing a school to manage a communicable disease case or event requires an inclusive and holistic approach to protect access to in-person learning for all students. OHA/ODE Recommendation(s)	Response:
Describe how you will ensure continuity of instruction for students who may miss school due to illness.	Provide flexible attendance and learning platforms with qualified instructors for students and families requesting accommodations for high-risk health needs. Baker School District implements a comprehensive plan for continuity of instruction, including online learning, credit recovery, academic and enrichment learning. The District has invested in technology, curriculum, and professional training to fully support these learning options.
Describe how you identify those in your school setting that are disproportionately impacted by communicable disease and which students and families may need differentiated or additional support.	Provide opportunity for staff, students, and families to self-identify as being at high risk. Work with the school health nurse to identify students listed as medically complex, medically fragile, or nursing dependent. Work with the Special Education Director and ESL Coordinator/Family Liaison to identify disproportionately impacted students/families.
Describe the process by which the school will implement a differentiated plan for those that are disproportionately impacted, historically underserved or at higher risk of negative impacts or complications related to communicable disease.	Ensure equitable consideration is given for students with special needs (e.g., low income students who rely on the school food service for daily meals), students requiring additional support (students with disabilities, mental, and/or physical health considerations), students identified as homeless, those in special facilities (e.g., juvenile justice facilities), as well as those who do not speak English as their first language. Provide flexible attendance and learning platforms with qualified instructors for students and families requesting accommodations for high-risk health needs. Under the guidance of the Special Education Director, establish interdisciplinary teams who will communicate with parents and health care providers to determine the current needs of each student identified as medically complex, medically fragile, or nursing dependent and modify health care plans, IEPs, 504s, or other student medical plans accordingly and ensure requirements for ADA and FAPE are met.

<p>Describe what support, training or logistics need to be in place to ensure that the named strategies are understood, implemented, and monitored successfully.</p>	<p>Ensure that the Communicable Disease Management Plan is updated, reviewed regularly by staff, and readily available/easily accessible to the public.</p> <p>Baker School District implements a comprehensive plan for continuity of instruction, including online learning, credit recovery, academic and enrichment learning. The District has invested in technology, curriculum, and professional training to fully support these learning options.</p> <p>Baker School District maintains an ongoing collaborative relationship with local public health authorities. The LPHA advises and provides consultation to the BSD leadership team regarding health and safety in schools. Input from community partners and key organizations has been solicited in the development of plans. Some of these partners include Eastern Oregon Coordinated Care Organization, Building Healthy Families, Baker County YMCA, Eastern Oregon Head Start, EI/ECSE, and the Confederated Tribes of Umatilla Education Center.</p>



### Section 3. Communicable Disease Outbreak Prevention and Response:

**Implementing mitigation activities, responding to periods of increased transmission, resuming baseline level mitigation, and debriefing actions to improve the process**

Planning for and implementing proactive health and safety mitigation measures assists schools in reducing communicable disease transmission within the school environment for students, staff, and community members. Communicable disease, including norovirus, flu and COVID-19, will continue to circulate in our communities and our schools. Schools will utilize different mitigation measures based on local data, and observation of what is happening in their schools (e.g., transmission within their facilities and communities.) In the following section, teams will document their school's approach to the CDC, OHA and ODE advised health and safety measures at baseline, during increased transmission.

<b>OHA/ODE Recommendation(s)</b> Layered Health and Safety Measures	<b>Describe what mitigating measures the school will implement to reduce and respond to the spread of communicable disease and protect in-person instruction?</b>
Immunizations	<p><i>CDC, OHA, and ODE recommend COVID-19 vaccination for all eligible individuals. Please include whether your school will offer COVID-19 vaccine clinics or notices about where to access vaccines in your community. <b>Shots are required by law</b> for children in attendance at public and private schools, preschools, child care facilities, and Head Start programs in Oregon. Nearly every place that provides care for a child outside the home <a href="#">requires shots</a> or a <a href="#">medical</a> or <a href="#">nonmedical exemption</a> to stay enrolled.</i></p> <p>Baker School District collaborates with our LPHA to provide easy access to COVID-19 and other vaccinations. COVID-19 vaccination is advertised and included in the vaccinations offered at the School-Based Health Center.</p>
Face Coverings	While the implementation of universal and correct face coverings is no longer an OHA requirement, the district supports all individuals who wish to continue wearing face coverings as a mitigation strategy.
Isolation	Baker School District follows OHA and ODE's Symptom-Based Exclusion Guidelines and asks that those who show symptoms of illness stay home. Baker 5J schools provide isolation areas for students and staff who exhibit symptoms of illness while at school, in alignment with ODE's Exclusion Summary Guidance for K-12.
Symptom Screening	Basic symptom screening is used to identify and isolate any staff or students showing symptoms of illness at school.
COVID-19 Diagnostic Testing	<p><i>OHA offers schools a diagnostic testing program to all public and private K-12 schools in Oregon. Please indicate whether your school will offer diagnostic testing.</i></p> <p>Medical staff managing the School-Based Health Center are trained in administering COVID-19 diagnostic testing. Testing is available daily at no cost for staff and students during school hours.</p>
Airflow and Circulation	Funding has been appropriated to continue upgrading the HVAC systems in existing facilities. Baker School District ensures common areas, classrooms, and health rooms are ventilated as much as practicable.

Hand Washing	Hand hygiene and respiratory etiquette is demonstrated to students and reinforced daily through visual and verbal reminders. Hand sanitizer stations are set up at entry of each school building; soap and water is available in restrooms and classrooms.
Cleaning and Disinfection	Baker School District utilizes appropriate disinfection and sanitization procedures.
Training and Public Health Education	Baker School District follows a plan developed in collaboration with our LPHA for communicating with students, staff, families, and the community regarding communicable disease-related information affecting the school environment.

Training exercises are essential to preparedness ensuring individuals understand their role in a communicable disease event. Exercises can also help identify gaps in the planning, thereby building upon and strengthening the plan over time.
