

- Profile Details, Name, Date of Birth, Occupation, Education, Images and Videos (Including but not limited to images posted to your Profile); Gender, Mobile Phone Number, Email Address, Sexual Preference, Location, Linked Accounts.
- (Apple or Facebook login details; Including but not limited to publicly viewable information, in addition to other information we use to verify your profile.)
- Your Password will be stored securely, we will not have the ability to view or provide your password, in the instance of loss or forgotten password, you may reset it at any time with a linked Email or phone number.
- If at any time, we explicitly request or you share more information with us, it is only intended to be used for the incidental purpose of a particular situation.
- (This differs from location service data we collect)
- We may or may not collect that information depending on the specific scenario.
- All data (Including but not limited to pictures, profile details, etc.) put into the app may be collected.
- If at any point you were to reach out to us by another means of contact differing from the Commune application, your IP address, in addition to your frequent IP address, may be collected for the intended purpose of securing your account (This may include new names or other information). We may collect this information in other instances as well.
- Please be mindful of the information you put on your Profile as it will be publicly viewable, use good judgment as a reasonably prudent person.
- To keep Commune a safe community we may scan and survey messages (when reported) in a thread to ensure users are adhering to our community guidelines and; terms and conditions. Addendum, any user who violates/breaches these terms may have their account blocked/banned.
- If you make an in-app purchase, we may use Apple as a third party transaction provider, we would provide them with your financial information to complete the transaction. Please refer to Apple's Privacy Policy to see how they manage your data.

- Conclusions drawn by any and all information afore listed to reach new assumptions, this is to better your experience and/or to be used as in a scenario that may call for it.
- Geolocation : (we may collect information about Wi-Fi access points, longitude, and latitude, device coordinates, frequency of visits, and duration) doing so allows us to better tailor your experience on the app. Note: This application requires you to allow location services. To modify this at any time please refer to settings. To properly function the app enables location services, with preferences set to “always”. THIS IS CRUCIAL to the functionality of the app, we need to place you to allow you to use the functions of the app. (Note: the is a location-centric application).
- Please note that at any point, if law enforcement agencies request or serve proper warrants, your information may be subject to turnover/handover. (We do not anticipate this being very common, however, in such an instance please note that we will do our best to accommodate law enforcement agencies to the fullest/best of our ability to resolve the matter.)
- In the event you delete your account we will delete all your information, however, we may hold your information for up to a year.
- Messages between you and other users might not be deleted, even if it contains personal data.
- Data Security: We will use encryption to transfer your data, to do our very best to keep your data secure.
- Excessive reporting/False reporting may result in suspension or potential banning
- All User Generated Content Must Follow These Guidelines:
 - All Usernames, Event details, and commune details must be respectful not using sexual or incendiary language
 - All event details must pertain to the event in question and only to that event
 - One may not specify any form of payment or cost in the event description
 - All information in the event details must be true and pertain to the event only
- All reported events will be reviewed and if and either approved to continue, be deleted, and the user who created it may also be deleted!
