By commissioning me, SuperSilly64, you agree to all of my Terms of Service. I reserve the right to rectify, alter, and nullify standards on special cases.

**Breaking my TOS will result in a blacklist and your rights to all provided services will be revoked.**

*If need be, special cases can be accustomed for with prior discussion.*

**Requesting taboo NSFW from the aforementioned Will Not Draw list will result in a block and a BLACKLIST from commissioning me, SuperSilly64.**

*I will simply turn down a kink if I'm not willing to do it – as long as it isn't considered a paraphilia, you will NOT be admonished for asking.*

## II. Pricing and Payment

### **Halfbody (Simple) - 90 USD**

*With Rendering + 30 USD | Every new character = + 90 USD*

### **Fullbody (Simple) - 120 USD**

*With Rendering + 30 USD | Every new character = + 120nUSD*

### **Full Scenes (Simple) - (1 char) 200 USD**

*With Rendering + 50 USD | Every new character = + 50 USD*

**For any commission requests outside of these listings, a custom quote will be provided.**

Payment is through PayPal and Cashapp. I will not start a commission until it is paid in full. *Holds longer than a week require a 50% down payment.*

## III. Commission Process

- ❖ By default, all my commissions are artistic liberty. It is heavily encouraged to be as detailed as possible to ensure the characterization of your request is brought to life as accurately as possible.

- ❖ Send me a flat-colored, detailed reference of the character you wish for me to draw. After payment, I will begin working on your artwork.
- ❖ You are welcome to request unlimited changes up until after the sketch is approved. **Afterwards, if you wish to change the lineart, you will be charged 10 USD for each hefty change.** Depending on the logistics of the change, I may deny them if it is far too major.
- ❖ After the commission is complete, you are welcome to ask for small changes in coloring and details to no expense. However, I will not change anything else outside of errors.
- ❖ I will send updates during the sketch changes, and when it is finished. If you wish, you are encouraged to ask for updates as much as you like. I only ask that you do not hound me.
- ❖ **TAT is typically 1-3 months.** Depending on your commission, it may be shorter or longer. I will provide you with ample logistical details at the time of the interaction. It's substantial to keep in mind that I am a part-time digital artist, and life and special circumstances may get in the way.

## IV. Adopts and Designs

Personal rights to designs are handed off to the buyer after the transaction is complete. You are welcome and encouraged to do whatever you please with my designs. Do not sell them for higher than what you brought if you have never gotten extra art. **UNLESS YOU SPECIFICALLY BROUGHT MY DESIGNS FOR COMMERCIAL/VTUBER USE, DOING SO FALLS UNDER COPYRIGHT INFRINGEMENT! You will be blacklisted.**

## V. Copyright Policy

As the artist, I reserve the right to publicly use and post artworks such as (not limited to): Marketing, Social Media Promotion / Publishing, and use it in listing examples.

*My commissions are defaulted for personal use ONLY. **Under NO means are you to make profit off of the artwork provided to you via redistribution, taking credit, or the like. Do NOT remove my watermark.** If you intend to commission me for commercial use, the pricing will be a **300 percent increase** and will be adjusted accordingly. Failure to comply with these policies will result in a blacklisting*

You may request an anonymous or private commission if you would not like the artwork or your name to be displayed on social media. There is no upcharge for private commissions.

## **VI. Cancellations and Refunds**

If for any reason, I cannot complete your commission, a full refund will be issued towards you. Depending on the reason, it may take time to get your refund.

I cannot refund you after the sketch is complete. If you would like a refund before the sketch is done, you will only get 50% of your payment.

I reserve the right to deny rude clients. Ill-mannered behaviour and poor commissioner etiquette is subject to a refund and a blacklist, as well as publicly posting you on social media to warn other artists. **I may deny a refund if the sketch was already approved.**

**Chargebacks are explicitly FORBIDDEN. If you attempt to chargeback me, you will be posted online to warn others for scamming. Do not do this!**
