

Terms & Conditions (the “Terms”)

Please note: Chiliz Tokens and Fan Tokens are not and shall not be construed as investment or financial products. They are a form of cryptoasset. Please note that when it comes to crypto assets (a) the value is variable and can go down as well as up; (b) these are unregulated in most places; and (c) tax may be payable by you on any profits made on their sale. You should carefully consider buying or selling cryptoassets as it entails risks and could result in a complete loss of funds. They are not suitable for those under-18.

1. This Competition is called “*POR Fan Token 50,000 CHZ Buy/Sell Contest!*” (the “**Competition**”).
2. The promoter of this Competition and Data Controller (for purposes of any data processing) is Entertainment Trading Technologies Ltd, bearing company number 218014, having its registered address at Suite 202, 2nd Floor, Eden Plaza, Eden Island, Mahe, Seychelles (the “**Promoter**”).
3. The Competition is open to participants who satisfy the conditions set out under the Clause 5 of the Terms. (“**Participant(s)**”/“**You**”/“**Your**”/“**Yourself**”).
4. The Competition will run from *July 26th, 14:00 pm CEST* (the “**Opening Date**”) to *Aug 1st, 14:00 pm CEST* (the “**Closing Date**”). Anyone who attempts to participate following the Closing Date will not be eligible to participate and will not be considered. Notwithstanding the foregoing, the Promoter reserves the right, in its absolute discretion, to consider submissions made after the Closing Date.
5. In order to participate in the Competition, you **MUST**:
 1. Be aged eighteen (18) or over;
 2. Have a [ChilizX](#) account and completed KYC2; and
 3. Buy/sell POR/CHZ pair in the amount of a minimum of seventy-five POR fan tokens (75) on ChilizX.
6. For the sake of clarity, residents of the United States, United Kingdom, Afghanistan, Burundi, Central African Republic, Cuba, Democratic Republic of Congo, Estonia, Guinea-Bissau, Iran, Iraq, Kosovo, Lebanon, Libya, Malta, Myanmar, North Korea, Pakistan, Russia, Somalia, South Sudan, Sudan, Syria, Venezuela, Yemen, Zimbabwe shall not be eligible to participate in this Campaign.
7. Multiple entries and user accounts created for the purpose of the Competition will not be considered. Fake accounts and bots shall be disqualified.
8. The Competition is limited to one (1) trader account per Participant. Participants found to have competed with more than one (1) trader account shall be disqualified from the Competition.
9. “Trading Volume” shall mean the sum of a Participant’s total buys and sells (excluding wash and any other type of illicit trades) of POR/CHZ pair on ChilizX during the above-explained Competition period. Trading Volume shall be calculated in the following way: Trading Volume = Sum (executed buys of POR/CHZ pair) + Sum (executed sells of POR/CHZ pair).

10. The Promoter accepts no responsibility whatsoever for entries not successfully completed due to a technical fault of any kind.
11. There shall be a total of fifty (50) Competition winners (the **"Winner(s)"**). The fifty (50) Participants with the highest Trading Volume shall be considered as Winners.
12. Based on their Trading Volume ranking, the Winners shall receive the below explained CHZ into their ChilizX account wallet. (the **"Prize"**).
 - The Winner with the highest ranking shall receive:
 - 1st place: 5,500 CHZ
 - 2nd place: 4,450 CHZ
 - 3rd place: 3,800 CHZ
 - 4th place: 2,800 CHZ
 - 5th place: 2,100 CHZ
 - 6th-10th place: 1,050 CHZ each
 - 11th-20th place: 850 CHZ each
 - 21st-30th place: 650 CHZ each
 - 31st-50th place: 555 CHZ each
13. The Prize is non-exchangeable, non-transferable and no cash alternative is offered.
14. Distribution of the "Prize" could be done in a maximum four (4) weeks after the Closing Date.
15. **The Promoter, in its sole and absolute discretion, reserves the right to substitute the Prize or a portion thereof with alternative prize(s) if circumstances arise beyond the control of the Promoter, rendering such substitution necessary. In the event that the delivery of the Prize or a portion thereof becomes unduly difficult or impossible to execute, the Promoter shall not be held liable for any expenses or damages incurred by the Participants in connection with the Prize. This provision encompasses any applicable regulations that may impact the Participants' ability to receive, hold, possess, or manage CHZ tokens, as well as instances of force majeure or other external circumstances beyond the control of the Promoter. Furthermore, if the local regulations applicable to the winner prevent them from receiving the tokens due to regulatory, legal, or any other reasons associated with token receipt, the Promoter reserves the right to withhold the Prize, either in part or in its entirety.**
16. Any reward in relation to the Competition shall be strictly limited to that described herein these Terms, and any other rewards, prizes or benefits are hereby being explicitly excluded.

- 17.** The decision of the Promoter regarding any aspect of the Competition and the Prize is final and binding and no correspondence will be entered into about it.
- 18.** Participants are deemed to have accepted and agreed to be bound by these Terms upon entry in the Competition. The Promoter reserves, at its sole and absolute discretion, the right to, at any time, refuse entry, disqualify, or refuse participation to anyone in breach of these Terms and/or any applicable law.
- 19.** If a Participant uses fraudulent methods or otherwise attempts to circumvent these Terms, such Participant shall be discarded at the sole discretion of the Promoter.
- 20.** The Promoter reserves the right to hold void, cancel, suspend, or amend the Competition at any time where it becomes necessary to do so.
- 21.** Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Participant or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the gross negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.
- 22.** By participating in the Competition, Participants accept and agree that, as a condition of entry, they agree to participate in publicity and marketing material related to the Competition which may include the publication of the Promoter (or any of its associated/affiliate entities).
- 23.** Personal data supplied during the course of this Competition may be passed on to third party suppliers only insofar as required for the fulfilment of the Competition, for the selection of the Participant, delivery of the Prize and marketing purposes.
- 24.** These Terms shall be governed by the laws of Seychelles. Any disputes arising out of or in connection with these Terms and/or the Competition shall be referred to the exclusive jurisdiction of the courts of the Republic of Seychelles, and the Participants of the Competition submit to the exclusive jurisdiction of the Seychelles courts and tribunals.

- 26.** Apple is not a sponsor or in any way involved in the promotional activities as contemplated in these Terms.
- 27.** The Promoter shall not be held responsible for the non-fulfillment or part fulfillment of any aspect of this Competition in case the same is due to any third party.
