# Welcome to the **Unofficial** Virtual Office Landing Tracker

This tracker is a crowd-sourced, user-inputted spreadsheet designed to assist individuals with approved Permanent Residency (PR) in Canada. It provides an estimated timeline for receiving your electronic Confirmation of Permanent Residence (eCoPR) based on shared user data. **Please note: This is not an official document.** All data is provided voluntarily by users aiming to share insights into the PR approval timeline.

#### Who Should Use This Spreadsheet?

- Your PR application has been approved and you have received the P1 email.
- You are currently located in Canada (inland canada).
- Your processing is handled by the Montreal office (your P1 email was sent from IRCC.ClientPortalEast-EstClientPortail.IRCC@cic.gc.ca).
- You agree to regularly update your data to maintain the accuracy of the spreadsheet.

#### **How to Add Your Information**

This spreadsheet is managed by its users with minimal moderation. Its accuracy relies on your contributions.

# Step 1: Fill out the Form

Complete the form to create a unique username (ideally the same as your Canada Visa Forum username). Please only do this once! Check the spreadsheet to make sure your information has not already been added

# **Step 2:Update the spreadsheet**

Locate the row with your username and update your data using the <u>provided URL</u>. Include key dates like P1, P2, and eCoPR. Ensure accuracy to maintain the integrity of the spreadsheet. Update whenever you receive P2, eCoPR, or need to correct an error in your initial entry.

## **FAQ**

#### When will I receive my eCoPR?

It's impossible to predict exact eCoPR issuance dates, but current trends (as of April 13, 2024) indicate that the Montreal office processes eCoPRs based on their expiry order. Use the spreadsheet to observe recent trends to estimate when you may receive your ecopr.

## How long after P1 will I receive P2?

Wait times vary; current data suggests a 1-2 week period between P1 and P2 as of April 13, 2024. Note that quicker P2 issuance often correlates with longer waits for eCoPR, and vice versa (this is just a trend noticed in the Montreal VO).

## How do I find out when my eCoPR expires?

Log in to your PR tracker account to view this date, which is typically the date of your medical exam or its approval. Alternatively, contact IRCC (1-888-242-2100) for this information, provided your application is approved and you have received the P1 email.

## Why can't I create a tracker account?

If you have a middle name you can try your first and middle name in the first name field. For example if your name is "John Henry" Doe you would write "John Henry" in the first name field in the tracker.

## Why is this taking so long!?

We've set up this spreadsheet so you can enter your details and spot any trends to help guess when your application might move forward. Unfortunately, this process does involve a lot of waiting. If you notice that others with the same eCOPR are also waiting, then you can safely assume you are experiencing standard delays. If it's been over two weeks since P2 and everyone else with your deadline has been processed, you might want to give IRCC a call or email to see the status of your account.

Also the following can delay your landing process

- Asking IRCC to update your information after P1 (like adding a spouse)
- Leaving the country during the landing process
