

Privacy Policy for Name Wheel Pro

Effective Date: 1 August, 2024

Introduction

Welcome to Name Wheel Pro ("we," "us," or "our"). We are committed to protecting the privacy of our users ("user," "you," or "your") and safeguarding your personal information. This Privacy Policy explains how we collect, use, disclose, and protect your personal information when you use our mobile application, Name Wheel Pro (the "App"). By accessing or using the App, you acknowledge that you have read, understood, and agree to be bound by the terms of this Privacy Policy. If you do not agree with the terms of this Privacy Policy, please do not access the App.

"wheels" or "wheels data" is referred to the title, list of names and Id that make a wheel which is further spun in the app to select random names from the list.

Information We Collect

We may collect and process the following types of information:

Personal Information:

Email Address: We collect your email address associated with your Google account for authentication purposes, wheels backup, wheels retrieval, wheels deletion and to uniquely identify each user within our system. We may also use your email address to communicate with you regarding important updates or security-related matters pertaining to the App.

User-generated Content (Wheels):

We collect and store (online) the wheels that you add within the App on your consent. This allows you to review and refer back to your saved wheels.

Account Name:

User Account Name: We use your account name from your Google account to enhance your App experience and display it in the app for you.

Use of Your Information

We may use the collected information for the following purposes:

To provide you the functionalities including but not limited to functionalities required for user experience and user interface.

To send you updates about the App through email.

For security purposes (any).

To monitor the usage of Firestore, our database technology, to ensure optimal performance and reliability. This monitoring is conducted at an aggregate level and does not involve accessing or using specific user information.

Please note that we do not use your personal information or user-generated content for purposes other than those outlined above unless we obtain your explicit consent or as required by law.

Access to Wheels data (saved online)

We understand the importance of maintaining the privacy and confidentiality of your wheels data within the App. We want to assure you that we do not access, use, or disclose your wheels data for purposes other than providing the intended functionality of the App unless there is a change in the policy. Here are some key points regarding the access and usage of your wheels data:

Limited Access: We have implemented measures to restrict access to your wheels data within our organization. Only authorized personnel, who need access for technical or support purposes, have permission to view the wheels data.

Non-Commercial Use: We do not use your wheels data for advertising purposes or share it with third parties for marketing or promotional activities.

User Control: You have the option to delete your wheels data from within the App at any time. Once deleted, the wheels data is permanently removed from our access.

We retain your personal information, wheels data, and Gmail IDs for as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law. You have the option to delete your wheels data.

We may disclose your personal information in the following circumstances:

To our service providers and partners who assist us in operating and maintaining the App.
To comply with legal obligations, such as responding to lawful requests and protecting our rights and interests.

Data Security

We will try to implement appropriate technical and organizational measures to protect your personal information, including Gmail IDs, from unauthorized access, use, disclosure, and loss. We will try to follow industry best practices to ensure the confidentiality and integrity of your data.

Updates to this Privacy Policy

We reserve the right to update this Privacy Policy from time to time. We will notify you of any changes by posting the updated Privacy Policy within the App. Please review this Privacy Policy periodically for any updates. Your continued use of the App after the posting of the updated Privacy Policy constitutes your acceptance of the changes.
