Data that we collect automatically

On Android-based devices, Google Play requires developers to provide a valid privacy policy when the application requests or manages sensitive user or device information. Some of our applications collect and transmit the advertising identifier.

On iOS-based devices, the Apple Store requires developers to provide a valid privacy policy when the application requests or manages sensitive user or device information. Some of our apps collect and transmit the advertising identifier

The data we collect

1. The data you provide us.
2. Contact information (such as name and email address).
3. Player name and password.
4. Profile information (such as profile picture).
5. Your messages to the Service (such as chat logs and player support tickets).
6. Other information you choose to provide us (such as data to identify a lost account).
7. Data that we collect automatically.
8. Data about your account and game progress.



9. Your IP address and mobile device identifiers (such as your device identification, advertising identification, MAC address, IMEI).
10. Data about your device, such as the device name and operating system, browser type and language.
11. Data we collect with cookies and similar technologies (see below).
12. General location data.
13. Accurate geographic location data (GPS, with your consent).
14. Information about your use of the Service, such as game data and your interactions with other players within the Service.

Data we collect from our partners

1. Data we receive if you link a third-party tool with the Service (such as Facebook, Google or Apple)
2. Demographics (such as to determine the approximate location of your IP address)
3. Data to combat fraud (such as abuse of game refund or advertising click fraud)
4. Data of the platforms in which the games are executed (as to verify the payment)

Non-personal data



For the purposes of this Privacy Policy, "non-personal data" means information that does not directly identify you. In addition, non-personal data means "aggregated" and "un-personalized" information

Information disclosure and security

In the following circumstances, we may disclose your personal information in accordance with your wishes or the legal rules:

1. Your prior permission.
2. By applicable law inside or outside your country of residence, legal process, litigation requests.
3. At the request of public and governmental authorities.
4. Protect our legal rights and interests. We take reasonable measures to protect your information against unauthorized access or disclosure. We encrypt the transmission of data on the pages where you provide payment information. However, it can not be guaranteed that any security or encryption method will protect the information from hackers or human errors.



Limits of age

Knowingly, we do not collect or solicit personal data, nor direct or direct interest-based advertising to persons under the age of 13, nor do we knowingly allow such persons to use our Services. If you are under 13, do not send us any information about you, including your name, address, telephone number or email address. No person under the age of 13 can provide personal information. If we learn that we have collected personal information about a child under the age of 13, we will delete that information as soon as possible. If you think we can have data from or about a child under 13, contact us.
