

Notes on Injunction Transcript from 10/10/17

17:13 Liam Goligher states that he began employment at Tenth in 2011.

23:20-24 Liam Goligher refers to the incident in the catacombs/basement of the church as sexual assault, not sexual harassment. This is significant, since at the defamation trial in March of 2019, he said that what he thought was utterly false in Mr. Snyder's letter of 01/18/16 was calling the incident sexual assault not sexual harassment. In other words, he was lying, since no one corrected Mr. Snyder's mistake for years, because they themselves did not know until the trial. Mr. Snyder also recalls that in the meeting on 01/26/16 Liam Goligher stated that the alleged rape/false imprisonment was what he thought was utterly false.

31:10-15 Liam Goligher denies knowledge of elder misconduct toward a female, despite the fact that an elder/administrator was fired in/around 01/18 for sexual harassment of a female employee.

31:20-25, 32:1-3 Liam Goligher falsely states that the illegal alien incident occurred before he came. The incident occurred in 2013 and Liam Goligher was fully aware of it, as shown by emails.

32:22-25, 33:1-4 Liam Goligher admits that the elders lied to the congregation regarding the departure of the music minister.

54:8-21 Liam Goligher denies having knowledge of when the alleged sexual assault (harassment) in the catacombs happened, even though numerous emails prove otherwise. The incident occurred on 01/13/13, when Liam Goligher was senior minister.

55:11-19 Liam Goligher again states that the illegal alien incident occurred before he came.

57:3-22 Liam Goligher denies that an alleged rape/false imprisonment occurred.

57:23-25, 58-62 the former music director, aka Mr. "X", is discussed along with naked spankings, the crime of bodily violence, and Tenth Presbyterian Church being disciplined by the Philadelphia Presbytery for mishandling the incidents.

63:15-25, 64:1-4 Liam Goligher states that it would be against his religion to sue Mr. Snyder. This is interesting since his lawyer threatened to sue him twice and is currently suing him.

66:12-19 Liam Goligher admits that Mr. Snyder has been peacefully protesting.

75:14-18 Mr. Snyder mentions that he has evidence that Liam Goligher lied regarding the illegal alien incident, by saying it did not occur on his watch.

76:17-25, 77-78 Mr. Snyder admits that he intentionally tried to make the leadership look bad; he did not say that what he said was false. The letter in question was addressed to the elders. So for example, Liam's co-defendant, George McFarland, had been an elder for thirty-five years, well before any of the incidents brought up by Mr. Snyder.

86:3-6 Mr. Snyder's lawyer mentions the documents he brought, but Judge Abbe Fletman declines to see them, saying a foundation had not been laid, despite the fact that Mr. Snyder had previously stated that he had files proving that Liam Goligher had lied about the illegal alien incident.
