 - a) Procured head ref for Santelli Cetrulo- Alex Giolla

 - e) December 14th is the first dual meet date.
 - f) Squad Deadline is 2/1. Same day as Santelli/Cetrulo
 - 2. Jackson- Vice President Report
 - a) Coach even a volunteer, they have to go through a school selection process. (Must have a "safe sport" training). Practice, Dual Meet, Tournament. It's big trouble
 - (1) They can bring sanctions on your school
 - (2) George: Our Santelli/Cetrulo insurance doubled because we had too many non-certified coaches on the floor. They are a liability to our fencers, your schools and the NJIFA. We haven't had problems so our rates are going down, but please follow the rules on coaches
 - (3) Jackson reiterates- clinics, coaching, practices, all of these things hurt your schools if they are not board approved.
 - b) Coaching during out of season time.

- (1) From state individual ending until the last spring championship, you are not allowed to talk to them about fencing, strip coach at a private tournament, etc.

- (3) September 1st, you are only allowed to talk to your fencers one time.
- (4) Can't talk about training, strategy....only logistical information.
- (5) This is up until the Monday of try-outs.
- (6) Can't have booster clubs to pay at private clubs if it is JUST your school
- (7) If you feel people are, you need to contact your ADs and the NJSIAA....NOT THE NJIFA
 - (a) Seniors who are graduating can be coached privately AFTER the season.

- c) No one objects....Motion carries.
- 3. Santelli Cetrulo Seeding Proposal
 - a) Proposal 2- This proposal is just to formalize the existing practice from 2017 and 2018. 2A: Change "In Round 1, all participating squads are divided into 6 equal or near equal pools of 7 or 8...." to " In Round 1, all participating squads are divided into equal or near equal pools of 7 or 8...."

RATIONALE: Simply remove the "6" from the rule, as we have expanded beyond 48 teams and could further expand beyond 56 teams.

2B: Change the first paragraph of the Round 2 format to "In Round 2, the squads ranked 1-8 in each weapon make up pool A, squads ranked 9-16 make up pool B. Squads ranked 17 and below will be divided into equal or near equal pools, C being no smaller than D, D being no smaller than E, etc."

RATIONALE: Now that we have expanded beyond 48 teams, it becomes difficult to ensure pools of 8 beyond the A and B pools. This will ensure that the top 2 pools remain at a size of 8, while allowing flexibility for the remaining pools.

- (1) This was something that has occurred since we have had a higher amount of teams. It is something that was done because of the by-laws stating we must have 6 pools.
- (2) Approved with Unanimous Consent
- b) Proposal 3- Add the following to the First Round rules:

 "If there is an absolute tie (% victories, victories, indicators, touches scored) in the 1st round between two or more teams, and not all affected teams can be placed in the same 2nd round pool, a barrage of C-B-A bouts will occur. If all of the affected teams were in the same 1st round pool, the results of their earlier match will be used as the barrage."
 - (1) This was a proposal that every year had been discussed as the solution to the issue if it came up. This allows us to place it in the Santelli/Cetrulo Rules.
 - (2) Approved with Unanimous Consent
- c) Proposal 1-

1A: Increase the seed value of an athlete with a USA Fencing C, B, or A from 3/4/5 to 4/6/8. No changes to the seed value for a D/E/U (still 2/1/0). RATIONALE: The old seeding method equated a Freshman with an A to a Senior with a D. There is no way this is a fair comparison. I contend that there is a big dividing line between a D and a C. Anyone

above this line (A/B/C) is a much stronger fencer and their seeding needs to reflect that.

1B: Increase the seed value for an athlete's year in school by 1. So instead of Freshman 0, Sophomore 1,

Junior 2, Senior 3, make them 1/2/3/4.

RATIONALE: For any team with 3 athletes, this is a zero net gain. In reality, nearly every team's seed value will go up by the same 3 points. Where this has any purpose is for teams with a short squad (ie, only 2 athletes in a weapon). By awarding 0 for a Freshman U, you are equating that athlete with a forfeited spot. With this change, 0 is only given for an absent athlete.

- (1) George Janto motions to hold it to the 2019-2020 season

 - (a) Ed from Indian Hills 2nds the motion
 - (i) All those in favor- 28

- D. Sweet Sixteen Seeding Proposal by Jared Hammond-
 - 1. Jared- We have subjective rankings and we need objective rankings.
 - a) Rolling Points- Get points for competing in Santelli/Cetrulo and rankings of districts

- b) Balances the playing field-
 - (1) Any procedures on a tie (Santelli/Cetrulo is the tiebreaker)
 - (2) Keep breaking it until you get differentiation.
 - (3) If all three squads are tied (foil, sabre, epee)? Not sure about this.
- c) What if Santelli/Cetrulo is snowed out.
 - (1) Rankings from the previous season will be used.
- d) Details need to be worked out
 - (1) Vote on changing the seeding proposal
 - (2) We can then work out the issues beforehand.
- e) District Champions don't get a bonus.
 - (1) Jackson says they do.
 - (a) Values the state tournament a little higher.
 - (2) Rebuttal: District champ shouldn't have to go on the road. Which is a possibility with the way it is written
- f) Re-Establish the Santelli/Cetrulo importance to the tournament.
- 2. George moves that we table this with a committee to clear up some of the issues.

 - a) If you want additional time, you can call a timeout immediately after
 - b) The opposing coach can then piggyback that side.
 - 4. Indicator gets expunged when a fencer competes but is not on the roster at major tournaments. It goes down V0 / D0 (Non-offending school gets

the victory, but does not earn indicators for a fencer no other group can fence).
