Focus on Recovery Point Charleston (RPC): Based on shared feedback, it was suggested that we focus efforts on RPC by encouraging a consistent AA presence at their in-house SOS Serenity on Stockton meetings (6 pm on Mondays, Wednesdays, and Saturdays). I spoke with Carrie C., RPC Director, about possibly hosting a quarterly District 9 workshop at Recovery Point. She said yes, the date is TBD.

Carrie shared that RPC needs sponsors for the women in their program.

Collaboration: Victoria H., District 1 A&T Chair, and I discussed working together to meet the needs of both districts (programs in District 1 also need sponsors).

Highland Hospital Meeting Update: The Friday at 6 p.m. meeting at Highland Hospital is still active but needs more support. Members from Mustard Seed consistently attend the meeting.

o There is no official rule from GSO on the required amount of sobriety before bringing a meeting into a treatment or accessibility facility. Districts and areas set their guidelines, often recommending:

o At least 6 months to 1 year of continuous sobriety

o Completion of a Treatment/Bridging the Gap workshop (District 9 last held an A&T workshop in Summer 2023)

o Having a home group, sponsor, and an understanding of spiritual principles and Traditions
