OPERATIONS COUNCIL RECOMMENDATIONS

- Generosity analysis of pledges from Mona Shannon.

Discussion: Over time, the number of pledges has gone down and the number of large pledges has gone up. This means the pledge total is dependent on a reduced number of pledgers. Karen reported that Mona Shannon as Generosity Co-Chair has reached out via email through Breeze to new members with a Frequently Asked Questions about Pledging document to supplement what they receive in the Pathways to Membership class. Adelaide suggested we might consider hiring a consultant to assist us on a plan to remedy this. Reverend Beth Molholland suggested the UUA Congregational Life might have programs or information that could also be of assistance.

- Refining the Operations Council Process
 - to include rationale, recommendations, pros & cons rather than a motion for the consent agenda - request from Board Chair, Jenny Hunt
 - Resource: Ops Council Process.docx

Discussion: The Board discussed how the Ops Council process of vetting requests and submitting agenda items and proposed Board motions has saved time, but that including those items in the consent agenda might not be best practice. Karen suggested that the Operations council Process document be edited and then accepted as a policy. Now that we've been using this model for a while, we can revise the document taking into account how it has worked. The Board creates policy and the Councils create the procedures to carry out those policies. The Board discussed Ops Council continuing to consult with all the players on an issue and present that to the Board with a proposed motion recommendation. Adelaide suggested we table discussion and have the Ops Council work on the process document and bring it back to the board. Matt mentioned that having ops council recommendations in the consent agenda might be an issue of board members not reading the consent agenda and being prepared to pull out items that need to be amended or discussed further.
