

The Exoneration of BungoTaiga

and the stalker and ex mods who harassed him

I am writing this to correct the record on a vtuber known as BungoTaiga. I am not a longtime fan nor was I connected to Taiga. I am an independent investigator, who happened across Taiga and enjoyed hearing his impressive voicework, but happened across some of the rumors regarding him as I dug a little into his background. I will be keeping my identity anonymous, as many of the actual pedophiles I investigate will stalk and harass anyone I associate with. I know that will make it harder to trust this document, and confirm it isn't just one of Taiga's friends, but I would rather that doubt, than draw additional harassers to him. I have directly talked to Taiga to discuss these issues after my initial investigations and ask questions. He has been cooperative and honest through my investigation. Upon deeper inspection, this is a case of harassment and IRL stalking performed against Taiga. As a former victim of stalking, harassment, I can empathize greatly with this situation, and want to correct the record with my findings.

BungoTaiga has been accused of being a pedophile and possible child abuser. However, something glanced over by the public are the two sources and the distributor of these accusations. Discussing these three brings a lot of context to the original doc, and brings its validity and purpose into question. The doc written on Taiga, that alleges he is a shotacon, pedophile, racist, transphobe, and that he is toxic, was pushed by his stalker, using an old doc made half a year prior by two of Taiga's former mods, [gilk](#) and [ahzy](#), both banned a few months apart and then the doc against Taiga appearing 3 weeks after Gilk was banned from Taiga's discord for calling Taiga a money whore. According to Taiga, Ahzy was banned for constant inappropriate flirting with other server members, including minors, and not performing mod duties, after constant complaints from Taiga's community.

His stalker was a known super fan of Taiga, and when I say super, I mean it. He has donated a total of at least half a million dollars to Taiga. He was an active member in Taiga's community. [Here](#) is a video of these superchats. He would push Ahzy and Gilk's doc, as well as host an entire website dedicated to "exposing" Taiga. According to Taiga, All three of these people tried to get closer to Taiga, in an intimate way, and were rejected, leading to the creation of the doc, and then the website. Adrian would buy and host this, under multiple web addresses. The [website](#) was cleared and it is now just a boilerplate statement indicating the stalker is supposedly done. This website was not the end of this though. The stalker, who is very rich, a self described millionaire, would fly from France to Canada, [driving](#) to Taiga's town to stalk him IRL. In the [video](#) you can [see](#) ["Exit 153 Spadina Ave Lake Shore Blvd"](#) which is in Ottawa Ontario. This was on Dec 23, 2021. He did other traveling around Canada, and did not leave the country until [Jan 18th 2022](#).

He also made threats of lawsuits against Taiga for simply discussing the stalking material. As he is extremely rich, he is able to bully, harass, stalk people, and make them fear attempting to get legal recourse with his large fortune. His threat to Taiga alleged commenting about his stalking amounted to "abuse", despite revealing Taiga's legal name all over his "expose" website. Taiga fears trying to legally go after the stalker, as he suspects the stalker's goal is to tie Taiga up in a costly legal battle he cannot afford, a very fair and valid fear. I have censored the [legal document](#) the stalker shared on twitter as it reveals Taiga's name and city. He also at times [attempted](#) to apologize to Taiga, after having labeled him a pedophile. An odd

move to be sure, if you confirm someone is a pedophile I cannot imagine wanting to apologize or get back in their good graces. However, despite claiming to be done months ago on his website, he is still harassing Taiga, going as far as [threatening](#) to sue Twitch for having Taiga on the platform.

He is also a hypocrite. The document which will be covered, alleges Taiga's commissioned content is pedophilia, going as far as [calling](#) drawings CSAM (Child sexual exploitation material, a term that only applies to material tied to abuse of real children). However, the stalker continues to commission [shotacon](#) and lolicon to this day on his [skeb](#) account. He has since found a new "Taiga" whose vtuber avatar is even more shotalike, and commissioned art that pretty explicitly implied they were in a relationship despite previously claiming to be heterosexual in his legal document against Taiga.

I was also able to track down ahzy's nsfw [twitter](#), in which he is [following](#) the user "[@shotacookie](#)", a currently active account, so the idea that he is "exposing" Taiga's commissions in good faith is null and void. He is clearly still fine with such content, and only used it as a tool to go after Taiga. Gilk is [following](#) multiple nsfw artists who have done loli art. While not the major focus of any of these artists, they all have it in their portfolio. It is possible he is unaware, but I was able to easily dig into these artists' portfolios and find this with ease, likely indicating he is only upset about such content when it's useful. Allegedly he also often posted photos of Gon and Killua from Hunter X Hunter, kissing, with the caption "how me and the homies be" in Taiga's discord, directed at Taiga, as shown in one of the follow up docs to this [defending](#) Taiga. This being not much different than the content he later used to make allegations against Taiga. All three should have been aware he had such content, and only seemed to be upset when they didn't get the relationship they wanted.

With this we can conclude the original doc on Taiga and its sharing is composed not with objective fact or safety of anyone in mind, it only exists to harm Taiga, and use any method possible to do so. However, this does not mean there cannot be truth in the doc, and it should be looked at nonetheless.

The "Expose"

Now, we should go over the document in question, which has now been deleted from Google. It's contents can be found [here](#), where it is covered by a youtuber along with two response pieces, one by one of Taiga's mods and Taiga himself. It opens with the pedophilia accusations. To address the elephant in the room, Taiga did privately commission the content he is accused of, and I leave it to you the viewer to make your own judgment on your feelings regarding this, I remain neutral, I have encountered entire groups of pedophiles, open MAPs, or "unironic lolicons" as they call themselves, who lust after real children, who absolutely want drawings and real child abuse conflated. It benefits them in an array of ways, such as distracting from direct child abuse and pulling attention to morally detested drawings, and allows them to draw people into debates of such content instead of focusing on actual abusive acts they perform. I have seen these tactics used on many occasions. In response to this [I stay out of the debate on morality of drawings](#). I hunt people who harm children. I won't accuse someone of hurting real children over the morality of art. However, I do not blame anyone who finds such content morally reprehensible, and [I will not object to negative views on it either](#), as there is an overlap between the two communities, [as long as the two forms of content are not conflated](#). Conflation of these topics makes my work harder, as I, other investigators, the police, and cybertipline have to start investigations asking "is this art I can do nothing about or actual crimes

being committed with real victims". It is a red flag, but not a smoking gun or actual evidence of abuse.

Speaking of actual harm to children, let's address "the joke". There is a dm where Taiga is speaking to someone who uncovered a minor posting lewds in their discord channel. Taiga asks for these lewds, and when the user states they're 17 years old, in response, Taiga says "ffs who cares". I was able to ask Taiga about this directly. He claims this is a horrible joke he knows was wrong and very deeply regrets, and he made this joke because he was an immature 19 year old. From all mentions of it, he seems to genuinely regret this, not only the fact that he said it and got caught, but understanding why a joke like that is not okay and how minors are frequently harmed in a very real way when such questions are asked, and even that asking for lewds not given to him directly isn't okay of anyone of any age. He even addresses this and his statements to me match up with his statement [here](#). For what it's worth, the fact that he acknowledges this, is very atypical from any actual predator I have seen.

He also joked about wanting to be touched by his gym teacher. This is a riff on [Mac](#) in "It's always Sunny in Philadelphia". An entire episode revolves around this concept. Not much more to say on that, it's actually just a joke, from a show with dark humor.

After this point, the doc is quite strange. It leads with accusations of pedophilia, and then shifts into drama. Accusations of "toxicity", and claims of racism and transphobia, with some screenshots that can't be verified, following accusations of pedophilia. Taiga's statement is that these parts of the document are fake and edited logs, and after admitting to his "joke", I do not see any reason he would lie on this, and admit the prior. Basically everything after this point appears pretty clearly to be a few or even a single individual who Taiga was angry with for spreading rumors. I will leave most of this to the doc released by one of his mods, [Helsang](#). I investigate child abusers, not drama. But from my observations, Helsang's document appears to be on point. While silently observing the discord before approaching Taiga with questions, I could find nothing but support for trans people, and no traces of racism in his discord while I was investigating it, in fact, it was downright welcoming.

Gilk would even follow up with a second document on "toxicity" and "abuse" to unpaid mods who could walk away at any point, who were not performing their job. Gilk fails to reveal the screenshots he provides are him speaking, which indicates "toxicity to mods" may actually be "toxicity to a mod". Frankly, this is petty drama, but it appears to be the real reason the doc was created. Not for any fear of harm to children, but because an unpaid discord and twitch mod was upset they got fired for not doing their "job". To release a doc claiming pedophilia, and half the document is on "toxicity", and then to create a new one with 17 pages about "toxicity" and 0 mentions of pedophilia, indicates, to me at least, that Gilk knew his claims were false, they included the one damning convo they could find and content they were perfectly fine with prior to hurt Taiga.

At this point, many of the accusations have become a game of telephone, bouncing from one person to the next, with nobody digging further, and nobody at all noticing the harassment Taiga himself is a victim of.

Summary

In summary, I have found clear evidence that the doc against BungoTaiga was created by individuals, including an irl stalker, whose only interest was hurting Taiga, with 0 interest in keeping children safe, or morally disliking certain content. The content he has privately commissioned, you will have to make your own judgements on the morality of, but direct abuse, it is not. The stalkers behavior towards Taiga, however, is unquestionably abuse and stalking, and has flown completely under the radar. In regards to him, Taiga is not actually the abuser, but the abused. He acknowledges and understands his mistakes, and seems to actively be looking for more ways to ensure his server members are safe. He even asked, after I revealed I was a pedophile investigator and looking into him, if I'd be interested in sticking around his server and helping keep an eye out for trouble. I declined, but this shows a genuine interest in keeping his community and members there safe, and willingness to invite someone who actively goes after people who do what he is accused of.

Always be cautious of expose's. As someone who has performed them, they are one of the least effective methods at going after predators and should be used as a last resort, and are frequently more than not, just people with beef going after each other. Despite him not actively using the label lolicon or shotacon for himself, even distancing himself from the term, many in the lolicon community are trying to flock to Taiga, including individuals who do cross the line into abusers hidden amongst them, he more than ever needs help, not belief in his stalkers accusations. Whatever feelings you have on Taiga are for you to decide, but you should base them off of truth, and not fiction written by irl stalkers.
