# Houseless Working Group Recommendation Item 1

We, the aforementioned members of the Human Relations Commission of Asheville, henceforth known as HRCA, stand in solidarity with the residents of Asheville and the houseless community

affected by inhumane encampment removal, hereby offer a formal recommendation to the Asheville City Council.

We, the aforementioned members of the HRCA, strongly recommend that the Asheville City Council swiftly remove the following Ordinances/City Codes Articles, City Code Chapter 12, Article III, Section 12-51, and Section 12-52, immediately ceasing encampment removals on city property. In addition, the aforementioned members of the HRCA recommend the Asheville City Council redirect ordinance enforcement and Federal Homeless Assistance funds to provide or improve sanitation receptacles at known encampment sites.

We the aforementioned members of the HRCA recommend these amendments be implemented 60 days from today, in order to prevent residents and visitors in and of Asheville from potential and/or continued health and public safety issues, and so that we may all move forward with good faith efforts supported by the Peoples of Asheville, our partners in the region, and Members of Asheville City Council, to make the City of Asheville a more equitable and inclusive place for all.

## **Houseless Working Group Recommendation Item 2**

We, the aforementioned members of the Human Relations Commission of Asheville, henceforth known as HRCA, stand in solidarity with the residents of Asheville, The HRCA Houseless Working Group, and the Houseless community affected by inhumane houseless encampment removal preceding an event of inclement weather that was witnessed world wide on February 1, 2021 in the City of Asheville. We, the aforementioned members of the HRCA hereby offer a formal recommendation to the Asheville City Council.

We, the aforementioned members of the HRCA strongly recommend for the Asheville City Council to swiftly and decisively accept and implement amendments to the following City Ordinances/City Code Articles: City Code Article 12-51 introduce and implement sub section (D), City Code Chapter 16, Article 1, 16-1 introduce and implement sub section (E), City Code Chapter 16 Article 1, 16-2 introduce and implement sub section (C), City Code Chapter 11, Article 1, Section 11-17 introduce and implement sub section (C), to Asheville City Ordinances/Asheville City Codes as follows: This Article is prohibited from enforcement in the event of inclement weather, three days prior to inclement weather and three days after inclement weather. Inclement weather as defined as: the existence of rain or abnormal climatic conditions (whether they be those of hail, snow, cold, high wind, severe dust storm, extreme high temperature or the like), by virtue of which it is either unsafe and/or unreasonable for unhoused individuals to be exposed to this weather by way of encampment removal.

We the aforementioned members of the HRCA recommend these amendments be implemented no later than 30 days from today, in order to prevent residents and visitors in and of Asheville from potential and/or continued health and public safety issues, and so that we may all move forward with good faith efforts supported by the Peoples of Asheville, The Buncombe County Commissioners, and Members of Asheville City Council, to make the City of Asheville an equitable and more inclusive place for all.

We, the aforementioned members of the HRCA strongly recommend that the Asheville City Council swiftly and decisively accept and implement the directives included in this recommendation to be completed in a manner that allows for a safe, sanitary, energy efficient, kitchen, community area, and outdoor facilities before the date of June 10, 2021, in order to ensure the City of Asheville is free from potential and/or continued health and public safety issues, in such a vital and important community center. And so that we may all move forward with good faith efforts supported by the Peoples of Asheville, The Buncombe County Commissioners, and Members of Asheville City Council, to make the City of Asheville an equitable and more inclusive place for all.
