NEW YORK CITY ON-CAMPUS HOUSING

First Year Students: Starting Fall 2024, all first year students and transfer students with freshmen status will be automatically enrolled in on-campus housing. Students may complete the Housing Preference Form or submit an Exemption Request via the <u>Housing Portal</u>.

Current Students: Current students interested in on-campus housing will need to apply for housing by completing the Housing Application via the <u>Housing Portal</u>.

A note about our rates

- All room rates are per student
- Rates include all utilities
- Rates do not include a <u>Meal Plan</u>
 - All residential students living in on-campus housing will be automatically enrolled in the Two plan. All First Year students will have a mandatory dining plan for both semesters of their first year (two semesters). All current students will have the option to opt-out.

RESIDENCE HALLS

STUYVESANT PARK RESIDENCE

Multi-bedroom suites with one to three students per bedroom and four to five students per suite. For the 2024-2025 academic year, Stuy Park will be the home to First Year students.

KERREY HALL RESIDENCE

Multi-bedroom suites with one to two students per bedroom and three to six students per suite. For the 2024-2025 academic year, Kerrey Hall will be the home to First Year students.

LOEB HALL RESIDENCE

Multi-bedroom suites with one to two students per bedroom and four students per suite. For the 2024-2025 academic year, Loeb Hall will be the home to Upper-Level students.

301 RESIDENCE

Multi-bedroom suites with one to three students per bedroom and four to six students per suite. For the 2024-2025 academic year, 301 will be the home to both First Year students and Upper-Level students.

HOUSING CANCELLATIONS

IMPORTANT INFORMATION:

- The Housing License Agreement is a binding contract that all residential students are required
 to sign via the Housing Preference form or the Housing Application. Approval to cancel the
 Housing License Agreement is not guaranteed unless a student is studying abroad, visiting or
 mobility, December graduate, withdrawing, and taking a leave of absence (see the definitions
 below). Please refer to your signed Housing License Agreement for any specific details
 regarding cancellations.
- All Housing Cancellation Requests must be made by submitting a Housing Cancellation Request Form via the Housing Portal. You can find the form under Housing and Residential Education Forms.
- All Housing Cancellation Requests will require you to provide a reason, a detailed explanation and supporting documentation. If you do not submit the supporting documentation your request will be considered incomplete and will not be reviewed.
- A student must have a Housing Cancellation Request approved in order to receive a refund of any housing charges in accordance with the <u>University's Refund Schedule</u>. In all cases of a housing cancellation being approved, the housing deposit is forfeited (if applicable). Note: If you decide to move-out and vacate your housing assignment, this does not constitute cancellation of the Housing Licensing Agreement.
- A student who is officially approved for a housing cancellation may also be responsible for additional housing cancellation fees. Please review the Additional Housing Fees below.

Spring Study Abroad

Students who plan to study abroad for the spring semester must submit a copy of their Study Abroad program acceptance letter when they submit their cancellation request form through the Housing Portal no later than December 2nd, 2024. Students must vacate their room by 12:00pm on Monday, December 16, 2024 to avoid fees.

December Graduates

Students graduating in December will be released from their housing contract for the spring term. Students should submit their housing cancellation request form through the Housing Portal after they have applied for graduation no later than December 2nd, 2024. Students must vacate their room by 12:00pm on Monday, December 16, 2024 to avoid fees.

Visiting & Mobility

Visiting, or mobility, students not staying at the New York campus for the spring semester must submit a Housing Cancellation Request form via the Housing Portal no later than December 2nd, 2024. Students must vacate their room by 12:00pm on Monday, December 16, 2024 to avoid fees.

Housing Withdrawal & Leave of Absence

If a student is withdrawing or taking a leave of absence from the University, they must submit an Exit Form in order to cancel their housing.
