[REDACTED] is a patient of mine that I have seen since 3/29/2021. His last visit was 7/25/2024. He is diagnosed with Autistic disorder, F84.0 (ICD-10) based on DSM-5 Diagnostic Criteria. This diagnosis has impacted Taylor's social life and has at times led to difficulties in maintaining employment despite being a hardworking and engaged employee. My work with Taylor has also addressed episodes of depression and anxiety that Taylor has had in response to impact of ASD on his life. This has at times led to the point of Taylor experiencing suicidal thoughts. I ask that you take these things into consideration when evaluating Taylor's eligibility for disability.

REASON FOR REFERRAL

Taylor sees Dr. Erica Skidmore for psychotherapy, and she referred him for an evaluation. Taylor was diagnosed with Aspergers Disorder in 2011. Taylor's father requested a psychological evaluation to determine whether this diagnosis is accurate.

BACKGROUND/OBSERVATIONS

Family: Taylor's mother died unexpectedly in 2013. Taylor is an only child who lives with his father. His father works in sheet metal. He spends significant amounts with his paternal grandparents. Taylor's father has a girlfriend with two young children. Taylor said he understands they developmental level, but it still bothers him when they break rules. Family history is negative for mental illness.

Developmental/Medical/Mental Health: After his delivery, Taylor's mother had congestive heart failure. Taylor was a healthy baby. He has never been hospitalized or had a major illness. In early childhood, Taylor had frequent night terrors which discontinued after removing artificial food coloring from his diet. Taylor is a very picky eater. Beyond only liking certain foods, he has restrictions about how his foods must be prepared. His food restrictions are sometimes dependent on setting. Taylor has always been overweight.

Taylor has worked in psychotherapy with Dr. Erica Skidmore. In 2014, he saw her for a couple months for anxiety regarding the death of his mother. He began working with her again this year because he was having difficulty socially in school.

In early childhood, Taylor had extreme difficulty adapting to change, which has only moderately improved. He is very concerned with maintaining a routine. Taylor said he has preferences for short-sleeved shirts and shorts, regardless of climate. He has become ill multiple times because of his clothing choices. Taylor is extremely rule-oriented and becomes very agitated if someone breaks a posted or stated rule. In early childhood, Taylor was obsessed with Thomas the Tank Engine. He often set up tracks throughout the house and filmed his trains.

Educational: Taylor is entering the 8th grade at [REDACTED]. He was held back in 6th grade following the death of his mother. He started 6th grade at [REDACTED] school where he experienced significant bullying. Taylor reported that he tried to comfort a girl who was crying. She knocked his hand away and her friend called him an insulting name. Other children broke into his locker and stole his things. He said he was called insulting names and was threatened. His mother pulled him out of school to homeschool him, but she died after only two days of homeschooling. His father continued the homeschooling through the rest of the school year.

In kindergarten, a school psychologist diagnosed Taylor with Aspergers Disorder, but there are no known

ORDER GRANTING BAIL FOR ABUSE CASES

Case Number

Pursuant to Code Annotated, Section 40-11-150 & 40-11-152, the Court has reviewed the facts of the arrest and detention of the defendant and determines and finds that the defendant: (check where applicable)

- 1. Is a threat to the alleged victim "victim" or other family or household member.
- 2. Is a threat to the public safety.
- 3. Is reasonably likely to appear in court.

 - (C) Used or displayed a deadly weapon, as defined in T.C.A. §39-11-106.

- A. The defendant is enjoined from threatening to commit or committing specified offenses set forth in the warrant and against the alleged victim or other family or household member.
- B. The defendant is prohibited from harassing, annoying, telephoning, contacting or otherwise communicating with the alleged victim either directly or indirectly. Contact includes but is not limited to telephoning, emailing, text messaging, communicating through the use of social media platforms, talking to, or using third parties to initiate contact.
- C. The defendant is directed to vacate or stay away from the home of the alleged victim and to stay away from any other location where the victim is likely to be.
- D. The defendant is prohibited from using or possessing a firearm or other weapon specified by the court as follows: _____
- E. The defendant is prohibited from possessing or consuming alcohol or controlled substances.
- F. The defendant is ordered to not abuse, threaten to abuse, hurt or try to hurt, or frighten the alleged victim and/or the alleged victim's minor children under 18.
- G. Any other order required to protect the safety of the alleged victim and to ensure the appearance of the defendant in court as determined by this court as follows: _____

H. Defendant is permitted to retrieve belongings if accompanied by law enforcement. Defendant must call non-emergency line & request assistance understanding assistance is subject to law enforcement availability time of call.

My name is Taylor Oliver and I am really struggling right now. A week and a half ago, I got into a car wreck while DoorDashing and suffered bruises and soft tissue injuries as a result and had to go to the ER. My car was crushed because I couldn't afford to get it out of the tow lot and I didn't have collision coverage to help me. Because of this, I'm without a car and a job. I was DoorDashing as my sole source of income because it's been hard for me to get a traditional job. I'm currently trying to get on disability (I'm autistic and have dermatitis), but we all know how long that process takes. Additionally, I am in a very toxic, abusive living situation. Aside from being autistic, I'm also a member of the LGBT community. My family is not supportive of me and doesn't understand my diagnosis. Before the accident, I was saving money to move out and had over \$200 to my name. My disability lawyer told me not to make over \$900 a month while trying to get

donation of any amount towards helping me get back on my feet would really help me out and be greatly appreciated. Thank you.
