### At 10:15 — Business Meeting

Now is the time for us to conduct our 10-minute business meeting. [First Sundays in June and December will be Elections.]

Timekeeper, please set the timer for 8 minutes and then 2 minutes.

All opposed? [Count hands.]

Any abstentions? [Count hands.]

[Tally votes and announce results:] This motion passes. [OR] This motion does not pass.

[Repeat process with other agenda items as needed until time is up.]

That's all the time we have for our business meeting. Agenda items not discussed today will be tabled until next month's meeting.

Let's close the business meeting with the "we" version of the Serenity Prayer:

God, grant us the serenity to accept the things we cannot change, the courage to change the things we can, and the wisdom to know the difference.
