Introduction

DarkNet Stealer Monitoring Software ("we", "our", "us") is committed to protecting your privacy. This Privacy Policy outlines how we collect, use, and protect your personal information when you use our services.

Information We Collect

1. Personal Information:

Registration Information: When you sign up for an account, we collect information such as your name, email address, phone number, and payment details.

Monitored Entities: Information you provide to monitor, such as email addresses, usernames, and other identifiers.

2. Usage Information:

Log Data: We collect information that your browser sends whenever you visit our website or use our services. This may include your IP address, browser type, browser version, the pages of our site that you visit, the time and date of your visit, the time spent on those pages, and other statistics.

Cookies and Tracking Technologies: We use cookies and similar tracking technologies to track the activity on our service and hold certain information.

To Ensure Security: Monitoring for fraudulent activities and maintaining the security of our services.

How We Share Your Information

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information except as described below:

Service Providers: We may employ third-party companies and individuals to facilitate our service, provide the service on our behalf, perform service-related services, or assist us in analyzing how our service is used. These third parties have access to your personal information only to perform these tasks on our behalf and are obligated not to disclose or use it for any other purpose.

Legal Requirements: We may disclose your personal information if required to do so by law or in response to valid requests by public authorities (e.g., a court or a government agency).

Data Security

We take data security seriously and use a variety of measures to protect your personal information. This includes encryption, secure servers, and access control mechanisms.

However, no method of transmission over the Internet or electronic storage is 100% secure, and we cannot guarantee absolute security.

Data Retention

Monitored data is retained for 7 days for Basic license holders and 30 days for Pro license holders.

Your Rights

You have the right to:

Update Your Information: You can request that we correct or update your personal information.

Delete Your Information: You can request that we delete your personal information, subject to certain legal exceptions.

Object to Processing: You can object to the processing of your personal information in certain circumstances.
