We don't collect location information for the purpose of providing our service.
- 3. Information you generate when using the Services: You may provide Information as part of your use of the Services, including any information you provide when creating a note in the Services. We don't share this information with others.
- 4. Information regarding your use of the Services, such as app use information, and interactions with our team by email.

Information received from third parties:

 Information we receive from third-party platforms: when you register through a third-party account (such as a Google account), we receive Information that may include your username, email address, and profile picture.

Your data

Clever Reminder uses third-party vendors and hosting partners to provide the necessary software, networking, storage, and related technology required to run Clever Reminder.
