Purpose of the CBOC Measure D Citizens' Bo	Julie Parks, Superintendent Brett McFadden, District Advocates Group	Brett McFadden presented on CBOC responsibilities for the Bond Council, Jones Hall. Jack Weir commented that a problem with many CBOCs is that they are provided information by the District Bond Council. This can be a conflict of interest. Jack Weir will provide training to members at our next meeting. Jack Weir also pointed out that it is not the CBOC who conducts the audit, but the District. Mr. Weir recommends using a separate auditing firm for the audit of the Bond.
