

Disclaimer Form and Waiver from Liability

A disclaimer form and waiver from liability (the "Declaration") for participants in activities organised by Stephen Mifsud and/or MustGo™ (the "Organiser"), which events are held both locally within the Maltese territory, as well as overseas.

All information contained herein is legally binding on the person signing this Declaration (the "Participant") in relation to any activities and/or events set up by the Organiser.

The Organiser and the Participant shall be referred to collectively as the "Parties".

The Participant shall not participate in any activities and events organised by the Organiser prior to agreeing to the terms and conditions of this Declaration.

Statement:

By signing this document, the Participant agrees and affirms that no charges or monetary claims concerning personal damages and/or other claims whatsoever may take place as a result of the Participant's involvement in activities and/or events set up by the Organiser. Furthermore, no charges or claims will be brought forward against the Organiser or any associated persons for damages that may arise as a direct or indirect result of taking part in any event and/or activity set up by the said Organiser.

The Participant understands that the activity and/or event they are participating in carries with it inherent risks which may involve physical injury to one's own person as a direct or indirect result of their participation. The Participant hereby declares that they are fully aware of this before signing the Declaration.

The Participant understands that the activity and/or event may be physically and mentally demanding and as such may require the Participant to be well trained and ready for the challenge. The Participant declares that they shall not hold the Organiser responsible for any personal injury that they may suffer due to over exhaustion, strain or any other cause whatsoever. The Participant further declares that any action which may give rise to any injury during the trip, or any effects thereof which may be felt after the activity and/or event, shall be the sole responsibility of the Participant, and consequently the Organiser is to in no way be held liable for any such injury or related effects.

The Participant understands that the activities they will be taking part in may be dangerous, especially if not conducted with due caution, and declares that they shall take full responsibility for any damages that they may sustain as a consequence of participation in such activities.

This document is legally binding and may not be altered.

All personal data contained in this Declaration shall be processed in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) ("GDPR").

Unless it is necessary for MustGo to retain the Participant's personal data following the completion of any organised event, the Participant's data shall be retained by MustGo for no longer than necessary following such completion, after which MustGo will delete, pseudonymise or anonymise such data. Certain personal data may be retained if so required by law and/or in the event of a potential or impending dispute or claim relating to any organised event.

The Parties agree to submit to the exclusive jurisdiction of the Maltese Courts.

Terms and Conditions:

- The 15-day Base Package includes:

 - Service of English speaking guides;
 - 10 nights in 4 star Accommodation;
 - 3 nights in 3 star Amazon Lodge Accommodation;
 - 13 Breakfasts;
 - 8 Lunches;
 - 10 Dinners;

 - Salvador | Traditional folklore show with dinner;
 - Amazon | Transfer with boat ride;
 - Amazon | Canoe tour and Piranha fishing;

- Full payment for the Event is to be made as follows:
 - €1,000 non-refundable deposit upon registration;
 - €1,000 second payment - Payable by 26th June 2026;
 - €1,000 third payment - Payable by 26th August 2026;
 - €1,000 fourth payment - Payable by 26th October 2026;
 - Remaining Balance - Payable by 15th January 2027.
 - If the Event is cancelled by the Organiser due to imposed travel restrictions and/or flight cancellations, the full payment will be refunded to the affected Participant, provided that the Organiser is reimbursed by third parties to whom payments would have been made such as airlines, transport, accommodation, etc.
 - If cancellations occur on the part of the Participant for whatever reason, a cancellation fee applies as follows:
 - Cancellations by 2 month or more: 100% minus the first deposit
 - Cancellations by less than 2 month: No refund
 - The Participant may substitute themselves with other interested participants (as long as approved by the Organiser), however may be subject to incurring additional costs in relation to the change of name procedures required for any ticket or any other form of documentation (Change of name charge) or the cost of flight, whichever is greater. A further administration fee of €50.00 will be charged.
 - The Organiser has the right to refuse any participants without the need to provide any reason for doing so.
 - The Participant shall abide by the terms and conditions of airline, train and any other carriage operators.
 - The Organiser shall not be responsible for:
 - Any changes in traveling scheduled by the Airline. Any additional costs

or change in price caused by such changes shall be borne entirely by the Participant;

- Any expenses arising from errors in the names and/or surnames of the Participant, as provided to the Organiser by the Participant;
 - Any loss of luggage or personal property prior, during or after transit, to and from any destination which is attributable to the transport or carriage operators;
 - Any liability for injury, loss, damage or expense attributable or caused by the wilful or negligent misconduct of any participant for the whole duration of the trip;
 - Any loss of any participant in cases where such participant decides to wander separately from the group. Any participant is free to wander around at their own risk;
 - Any of the Participant's abusive, threatening, drunken or other anti-social behaviour, or the carrying of offensive weapons or illegal or prohibited substances. The Organiser dissociates himself from any such behaviour; and
 - Any vaccinations and visas, as may be requested by the visiting country/ies.
- Any discrimination based on any ground such as sex, race, colour, ethnic or social origin, genetic features, language, religion or belief, political or any other opinion, membership of a national minority, property, birth, disability, age or sexual orientation shall be prohibited. Furthermore, any and all direct or indirect reference to politics is forbidden.
 - Each Participant shall wear the official MustGo™ T-shirt:
 - when traveling in airports; and
 - whenever the Organiser instructs the Participant to do so.Failure to abide by the above garment instructions will hamper the Participant's chances of joining future MustGo trips.
 - The Organiser strongly urges the Participant to purchase travel insurance.
 - The Organiser urges the Participant to acquire an EHIC (E-111) card to safeguard themselves against any potential medical emergency.
