We invite you to submit proposals for paper presentations at the #IFM2024 Virtual Conference, taking place from June 12-14, 2024. While we encourage submissions that explore the themes of *Communities, Structures, Entanglements*, we welcome proposals on topics relevant to the broader IFM community.

ABSTRACT SUBMISSION AND REVIEW

Submit a 500-word abstract in English that outlines your arguments, research objectives, theoretical framework, methodology, and hypotheses.

- To propose a paper, complete the form below in English.
- Save this form as a WORD DOCX file, renamed with your last and first names (e.g. Smith_John_PaperProposal.docx) and upload it on the [#IFM Journal's Submissions](#) page by the deadline.

EVENT DETAILS

The conference will be hosted online via Zoom and is free of charge. No registration fees apply for either presenting or auditing. The conference language is English; no translation services will be offered.

PRE-CONFERENCE MATERIAL

Accepted proposals must submit a pre-recorded video presentation and a presentation paper one month before the conference (see deadlines). The video will be published in the #IFM Journal and assigned a DOI number.

- Paper video presentations should not exceed 20 minutes; see the website for technical specifications..
- Papers should be no more than 4,000 words, excluding the abstract and bibliography, and follow the Chicago Style 17th Edition. Consult the author guidelines on the website for more details.

PANEL DISCUSSIONS

As all accepted video presentations will be accessible online prior to the conference, panel sessions will focus primarily on discussion. Presenters will receive individualized feedback from facilitators, respondents, and participants.

PROCEEDINGS

Authors have the option to submit their finalized papers to the IFM Journal. Articles should be full papers, subject to double-blind peer review, and range from 5,000 to 9,000 words.
