Please read the TOS. It contains important information and I will not accept commissions that have not submitted an agreement.

1. General

- a. You must leave my signature/watermark on all completed art. I reserve the right to use my work as examples for future commissions.
- b. I aim to complete commissions within two weeks of payment on smaller projects, and one month for larger projects.
- c. DO:
 - i. Provide a full reference sheet or, if you do not have one, at least three images of the character
 - ii. Provide a detailed description of what you want, including pose, expression, etc.
 - iii. Provide two ways for me to contact you (a primary and secondary)
 - iv. Ask questions!

d. DON'T

- i. Harass me. I am also a human with a life, so treat me how you'd like to be treated! If you don't like the way I do things, you don't have to commission me.
- e. I will draw:
 - i. Humans and humanoid characters
 - ii. Animal/feral characters
 - iii. Furry or Anthro characters
 - iv. Some blood and gore
- f. I will not draw:
 - i. Real people
 - ii. Heavy mecha
 - iii. Heavy gore
 - iv. NSFW, fetish material, or sexual content
 - v. Anything I am uncomfortable with.

2. Financial Contract

- a. I reserve the right to deny or refund any commission, in the circumstance I would need to. If something prevents me from completing a commission, I will inform you and refund you.
- b. I take payment in full upon works less than \$50. For works over \$50, I will take half upfront, and half after a completed and approved sketch.
- c. I will provide a sketch via your preferred method of contact. At this stage it is up to you to let me know what I should change. Once the sketch is approved, no more changes will be made to the lineart. I am happy to do minor color corrections or shading and effects corrections after sending the final version.

3. Adoptable/Premade Designs

a. You are permitted to change aspects of the obtained design, such as name, backstory, details, colors, etc.

b. You are not permitted to sell the original image for more than it was obtained for.

c. If uploaded to Toyhouse, please credit me (@queen_of_the_m0on) as the designer.

4. Custom Designs

a. At this point in time, the only customs I have available are moodboard customs. Everything in the "General" and "Financial Contract" section still applies.

- d. Please provide a moodboard with the desired aesthetic/vibe for the character, along with a few "must-haves" for the design (species, accessories, etc). Other than that, it will primarily be artistic liberty.
