Dear Oklahoma CSR,

If you were unable to attend an OCRA convention this year, OCRA is offering CE credits via electronic format. A link will be provided so that you can download/stream the session(s) to view on your computer. You will complete the test online. The test will automatically be scored and, if successfully passed, a Certificate of Completion will be generated. You must have access to high speed internet to download the files. **No DVDs will be available.**

As required by 20 O.S. 1503.1, “Every certified shorthand reporter and every court reporter temporarily employed by the district court, Workers’ Compensation Court, or Corporation Commission shall annually complete at least four (4) hours of continuing education approved by the State Board of Examiners of Certified Shorthand Reporters. Included in the four-hour minimum requirement for every official shorthand reporter and every court reporter temporarily employed by the district court, Workers’ Compensation Court, or Corporation Commission at least one (1) hour shall relate to Oklahoma court rules and procedures. All four (4) hours of continuing education shall be approved by the State Board of Examiners of Certified Shorthand Reporters.”

OCRA is offering a total of four hours of CE credits, which includes one (1) hour of Court Rules & Procedures. OCRA is also offering the standalone purchase of Court Rules & Procedures at a separate rate. Please note order **deadlines and due dates**. Order online at <https://ocraonline.org/events>

## INSTRUCTIONS FOR ONLINE CEU

Once you complete the order form, you will be emailed instructions and the link(s) to download/stream the respective file(s). An additional link will be provided to take the test online. The test(s) will be automatically graded, so you'll know your score immediately after taking it. Upon successful completion of the test, a Certificate of Completion will automatically be sent. The written test(s) consists of 20 questions. The pass rate is 70%.

If you are applying for Oklahoma CE only, you will need to download the [2021 Annual Report of Compliance](#). It is **YOUR RESPONSIBILITY** to complete the form and mail to the Administrative Office of the Courts. AOC will then verify the hours completed with OCRA.

If you are applying for NCRA credits as well, the form can be located at <https://www.ncra.org/home> and has to be submitted electronically. It is **YOUR RESPONSIBILITY** to fill the form out online and submit it to NCRA with the Certificate of Completion attached.

**The Certificate of Completion MUST be attached to the Compliance Form to receive credit.**
