

# CA School Garden Coalition Communications Toolkit Amplify the Movement for School Gardens

## **Communication Toolkit:**

This toolkit is designed to help spread the word about the SB 341, the CA School Garden Coalition, and invite others to join our mission. Below are sample messages and resources to share with your network. Feel free to tailor them to fit your audience and communication style.

# Talking Points for **SB 341**

- 1. **Expanding Hands-On Learning** SB 341 lays the foundation for all students to benefit from instructional school gardens, <u>improving</u> academics, health and nutrition, career pathways, environmental literacy, and more.
- 2. **Building a Plan for Sustainable Funding** The bill restarts and begins the process to update California's <u>Instructional School Garden Program</u> (ISGP), which went unfunded and unused during the Great Recession and COVID-19 pandemic, creating a <u>phased-approach</u> for long-term funding and implementation.
- 3. **Addressing Inequities** Only about <u>9%</u> of school gardens are actively used, mostly in high-income districts with private funding. SB 341 sets the stage for equitable access statewide.
- 4. **Cost-Effective First Step** Requires only a 5% FTE workload from the California Department of Food and Agriculture to establish a working group and develop a plan, making it a low-cost, high-impact investment.
- Bipartisan and Education Leadership Support Led by Senator Sasha Renée Pérez (D-Alhambra) with coauthors Senator Rosilicie Ochoa Bogh (R-Yucaipa) and Senator Susan Rubio (D-Baldwin Park). SB 341 is <u>1 of 41</u> California bills with bipartisan co-authors (of 2,278 bills introduced this session)
- 6. **Statewide Benefits** A phased approach could reach <u>1 million students</u> within three years for about <u>0.5%</u> of the state's per-student base funding.
- 7. **Take Action** Help pass SB 341! <u>Sign on</u>, share, and join our movement for hands-on, outdoor learning in every California school.
- 8. **Background** The unused, unfunded ISGP <u>previously</u> issued some \$2,500 grants to schools for building school gardens. SB 341 calls for the inclusion of **instruction and maintenance** to ensure longevity of educational garden programs.

On behalf of the <u>CA School Garden Coalition</u>, I am inviting you to sign on in support of <u>SB 341</u>, a bill that takes a critical first step to update and expand California's <u>Instructional School Garden Program</u> (ISGP) to include instruction and maintenance so all California students can have ongoing access to garden-based learning.

# Why SB 341 Matters:

- The unused, unfunded ISGP <u>previously</u> issued some \$2,500 grants to schools for building school gardens. SB 341 calls for the inclusion of **instruction and maintenance** to ensure longevity of educational garden programs.
- Despite broad <u>support</u> for garden-based education and proven academic, health, and environmental <u>benefits</u>, the vast majority of **school gardens remain <u>unused</u>** due to a lack of dedicated funding for instructional programs and maintenance.
- Only about <u>9%</u> of school gardens are actively used for instruction, mostly in higher-income districts where parents typically raise private funds in addition to grants.
- SB 341 does not provide direct funding but creates a <u>phased plan</u> to bring instructional school gardens to more schools statewide.
- This bill is a **cost-effective first step** (5% FTE) toward long-term program sustainability and equitable access to hands-on learning.
