INTRODUCTION (Times New Roman, Bold, 12 pt, Align text center)

Introduction (Times New Roman, 11 pt, justified, single-spaced) must present concise background for general readers and cite relevant prior studies.

MATERIALS AND METHODS (Times New Roman, Bold, 12 pt, Align text center)

Materials and Methods (Times New Roman, 11 pt, justified, single-spaced) must detail experimental procedures for reproducibility. Keep concise, citing standard methods unless heavily modified. State scientific and cultivar names, material size/number/manufacturer, and describe treatments, design, and statistical methods. Common methods may be briefly noted with references.

RESULTS AND DISCUSSION (Times New Roman, Bold, 12 pt, Align text center)

Results and Discussion (Times New Roman, 11 pt, justified, single-spaced) should present detailed findings with tables/figures only when necessary. Avoid repeating results; instead, explain their significance, conclusions, and differences from previous studies. Results and discussion may be combined if it aids clarity.

Avoid repeating the Abstract or listing results. Indicate applications, extensions, and suggest future or ongoing research.

REFERENCES (Times New Roman, Bold, 12 pt, Align text center)

References (Times New Roman, 11 pt, justified, single-spaced) must follow the author—year system in Harvard style, arranged A–Z. Include 10–20 references (340–670 words), with ≥80% from journals and mostly primary sources (last 5 years). Do not cite unpublished data or personal communications. "In press" articles may be cited with journal name and publication date (if available).

Reference lists help readers locate sources. Each entry includes author(s), year, title, city, publisher, and pages. Use Harvard style: Last name, Initial. (Year). Title. City: Publisher, page(s). List alphabetically by author; if the same author, order by year.
