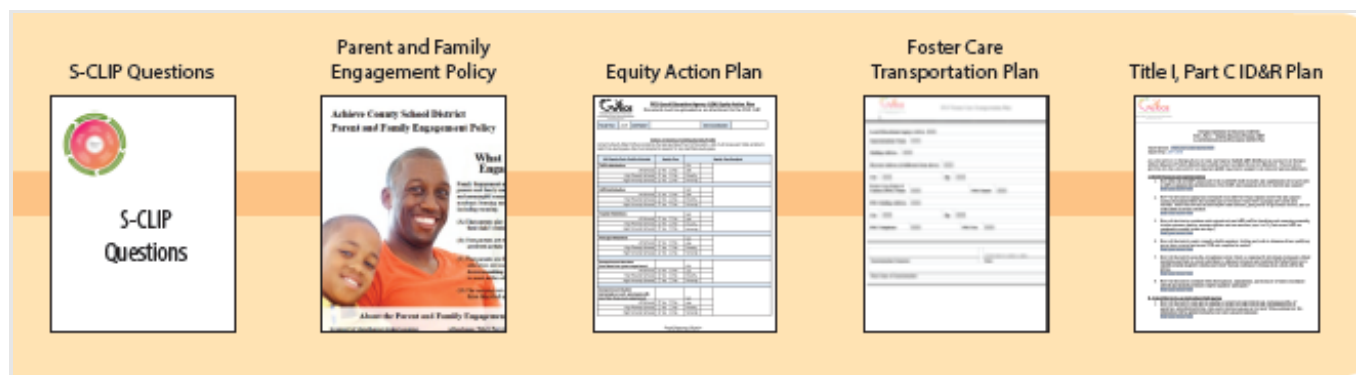

1. Describe the process the LEA used to engage required stakeholders (families, community-based organizations, school and district staff/leaders, local government representatives/agencies) in planning for continuous improvement through its locally-developed school improvement process and/or current strategic plan and/or charter system contract.

Madison County, an award-winning Charter System, has a continuous improvement process which includes a well-established and embedded strategic planning process. Annually, Madison County engages required stakeholders in planning for continuous improvement. All faculty and staff are surveyed for input around continuous improvement/strategic planning. The district and each school complete a comprehensive needs assessment and seek input from the local governance teams, as outlined in the charter contract. They also conduct focus groups with building leaders, parents of ALL students, governance teams, and community members to both identify needs and seek possible solutions/actions for improvement. The Superintendent and BOE host an annual strategic

planning meeting (every 5 years) where stakeholders (educators and community) work collaboratively to revise the strategic plan to address identified needs around the five areas of continuous improvement. Annually, the district hosts a safety meeting with school and community stakeholders. During this time, stakeholders have the opportunity to review the Strategic Plan, the CLIP, and other Federal Program Documents to provide feedback. Teachers and families of ELs are included in planning for continuous improvement. Teachers of ELs participate in a focus group that meets monthly and also completes all staff/stakeholder surveys. Families of ELs are invited to school events where input around their needs is sought. Representative stakeholders of ELs are invited to the annual strategic planning meeting and to participate in focus groups. All documents are publicly posted on the website with an opportunity for ALL parents to provide input.

2. Describe the process the LEA used to engage required stakeholders (families, community-based organizations, school and district staff/leaders, local government representatives/agencies) as part of its locally-developed school improvement process to address the needs of subgroups.

In addition to the district, each school conducts focus groups and meetings aimed at data analysis and disaggregation by subgroup. CCRPI performance flags, SLDS data, and analyzed benchmark data are used to determine strengths and needs of all subgroups. Educators, local governance team members, community members, and parents are given the opportunity to both understand the current level of performance of subgroups, identify needs, and provide input on solutions and action items. The Superintendent and BOE strategically select parents, educators and community members to attend the annual strategic planning meetings (every 5 years) so that each subgroup of students is appropriately represented and considered in the continuous improvement process. Separate focus groups/needs assessment meetings are held for children and youth experiencing homelessness and migratory children.

In addition to our annual EL Nights, the district also has a Community Outreach Night for our ELL population where community organizations join together to share resources. During this time, parents are provided information and resources to build capacity.

The district participates and provides a location for our local MART (Madison Area Resource Team) where the district, schools and community organization provide any families who attend with back-to-school resources and a job fair. Our MV/Migrant Liaison is a Board Member for MART.

The district and each school annually conducts a comprehensive needs assessment with stakeholder input. The CNA is a google document that is similar for all seven schools. Data from multiple sources and across at least three years are considered and analyzed. Data analyzed includes Milestones achievement data - school, district, RESA and state averages and rankings; weighted content mastery; growth model data; CCRPI performance flags for each subgroup; lexiles; universal screening results in reading; early warning system indicators; ACCESS data for English Learners;

achievement results for migrant compared to non-migrant peers; achievement results for gifted students; MTSS tier data; discipline data including specific subgroups; equity data; attendance data by school and district; behavior data from SWIS and any other locally determined data that schools determine to be relevant to the needs assessment process.

Once the data is analyzed, common threads and trends are identified and discussed. A specific emphasis is placed on needs/trends around the Title IV areas of well-rounded educational opportunities, safe and healthy students, and effective use of technology. After identifying common threads, a root cause analysis is conducted to drill down to "why" of each identified issue. Finally, a list of prioritized needs for each school and/or the district is generated using the previous processes. Using the prioritized needs, a school improvement plan and a district strategic plan is developed with required stakeholder input as described in the questions above.

The school improvement plan/strategic plan includes SMART goals and actions to address identified needs along with responsible personnel and timelines for implementation. By intentionally reviewing these, MCSS is able to increase professional capacity at the district and building levels. Each plan effectively addresses the five systems of continuous improvement.

School and district plans are revisited for impact checks and effectiveness at monthly leadership/staff meetings and data meetings at each individual school, with a specific emphasis on progress toward meeting SMART goals (leading data). These types of experiences and opportunities create a professional growth atmosphere. Finally, summative end-of-year data is analyzed to determine progress toward SMART goals and listed publicly in the "report card" with red, yellow and green indicators. Adhering to the cyclical nature of continuous improvement, the process starts over for the upcoming year.

Through an embedded data analysis process that utilizes predictive analytics, both the schools and the district use a combination of summative data (CCRPI data) and formative data (universal screening, benchmarks, MAP and common formative assessments) to identify the lowest performing students. Problem solving teams utilize the see-plan-do-check cycle of continuous improvement to identify and address the needs of lowest performing students through the MTSS - Multi-Tiered System of Supports. Tiered interventions for both achievement and behavior are implemented and progress monitored to ensure appropriate levels of support to promote student success. Federally funded services for ED, EL, children in foster care and students with disabilities are consolidated with state and local funds at the school level in order to supplement and support the MTSS process, allowing maximum flexibility to address identified student needs. Federally funded services for migratory and homeless students remain un-consolidated but are strategically implemented in a supplemental way that continues to provide additional services to address the unique needs of these vulnerable populations through the MTSS process. Implementing the MTSS process in a way that serves the unique needs of ALL students, including those who are the lowest achieving, is an action step in the district's Strategic Plan.

The Madison County School System coordinates services, supports, agency/community partnerships and transition services for children served across its Federal Programs. Funds from the following Federal Programs are consolidated with state and local funds at the school level: Title I - Part A, Title III - Part A, Title V-Part B and IDEA. Title II- Part A and Title IV- Part A are transferred to Title I - Part A. Title I-Part C and Title IX- Part A are not consolidated. These funds are managed by a Migrant/Homeless Program Specialist who coordinates with a host of agency and community partnerships by participating in monthly meetings of our Madison Area Resource Team (MART) which includes agencies and services across the county. In addition to supplemental services such as tutoring and transportation, migrant and homeless families are connected with community resources and services as identified through case management. Our McKinney Vento liaison is consulted ongoingly. While consolidated, IDEA funds are directed toward student and staff needs to better educate students with disabilities and ensure the goals and objectives of each written IEP are met. Services for students with disabilities are coordinated across schools and via agency/community partnerships. Transition services are an integral part of the service plan for students with disabilities.

The Madison County School System does not currently have CSI or TSI schools. Should schools be identified in the future, school improvement funding will be consolidated with state and local funds at the school level to maximize coordination and flexibility of funds to more directly address identified students' needs and coordinated services. If identified, Madison County Charter School System will attend all GADOE professional development opportunities and collaborate with the School Improvement Director.

The following initiatives/programs support improved graduation rate outcomes: PBIS (including attendance rewards such as attendance rewards), YouScience at the middle and high school, Reading Support Courses from grades 6 to 12 (the middle and high school employ full-time reading specialists), the Resource Class with small group instructional setting (serving students who are working toward a regular diploma but are not successful in the co-taught classroom). Students are provided more one-on-one instruction with intensive individualized instructional strategies).

The regional DHH program is housed within the resource classroom setting in Madison County. In addition, the high school offers credit restoration and credit recovery options. Students can also take advantage of Foothills Regional High School--which has a site on the MCHS campus--if they need an alternative schedule (4:30 pm to 8:30 pm Monday to Thursday, with students progressing through courses at their own pace).

MCCSD employs a CTAE-CTI coordinator at MCHS who monitors post secondary outcomes and supports students through advisement for transition following HS VocRehab also provides opportunities for students to learn job related and embedded skills in the community. The SPED director monitors and inputs this data for post-secondary outcomes. This data will be entered into the portal. The CTAE-CTI coordinator monitors and participates in the development of transition plans and identifies if staff needs further PL on implementation of transition plans.

We have a strong Child Find and early intervention program. Staff are continuing to work with preschool SWDs to improve outcomes in positive social/emotional skills, acquisition and use of knowledge and skills, and use of appropriate behaviors. Case managers for preschool students communicate directly with elementary staff to ensure a smooth transition to kindergarten. MCCSS offers a variety of service options in the community (Headstart, day care, & private pre-school) as well as in our Pre-k classes at our ELC (Early Learning Center). MCCSS has a Pre-school coordinator that is located at the ELC. The SPED director monitors new referrals and is available for any technical

assistance due to being located in the same building. The pre-school coordinator organizes all screenings, supports pre-K teachers and schedules all services as needed. The pre-school coordinator, the director of the ELC and the SPED director works together to support teachers and students by meeting monthly to review student needs. Pre-school screeners are scheduled monthly and are held at the ELC. A school psychologist is assigned to the ELC to support and to evaluate students. The screeners are advertised using flyers posted at daycares, doctors offices, private pre-K facilities, school system websites, and in the newspaper

- Special education staff receive yearly/annual training on LEA procedures that focus on updates and specific needs as they arise throughout the year. Special education teachers participate in monthly and quarterly new teacher training. Monthly ISC meetings are held with the Special Education Director and District Special Education Coordinator to support and insure procedures and policies are being implemented and followed with fidelity.

We provide services in co-taught, small group instruction (self-contained and resource), and collaborative settings by certified staff. Case managers provide current documentation of IEPs to the required stakeholders who work with and instruct students with disabilities. FAPE is provided to all eligible students from the age of three years old until their twenty-second birthday and they receive instruction through the Georgia Standards of Excellence and the Georgia Early Learning and Development Standards.

We will continue to support the provision of research based interventions and support for behavior by providing ongoing behavior strategies and support from the District Behavior Specialists (new position) as well as in-depth FBA and BIP training for case managers and appropriate staff. In addition, we will continue certifying and recertifying professionals in the Mindset De-Escalation model. We have three teachers who are Mindset trainers for our district.

The SPED department will monitor, support and schedule the implementation of Mindset training. Through our Equity plan, we are addressing the disparities in SWDs reading achievement. We will provide professional learning around this disparity. New teacher monthly meetings will address IEP/eligibility procedures, FBA/BIPS implementation, classroom-management, and parent/teacher communication. We employ a parent mentor that provides quarterly parent-to-parent training. The SPED Department is available for technical assistance for all staff and parents by email or phone, attends regularly scheduled IEP meetings, and meets monthly. The case managers share and discuss IEP accommodations that are documented in a student's IEP with the general education teachers during pre-planning.

At the district level, due process is implemented to ensure that we are compliant with process, procedures, and Individual Education Plan (IEPs). The district monitors the SIS, and we have a central registration process for new enrolled students. We have a Registrar, Student Records Coordinator, and Special Education Director who are available to assist when needed. At the individual school levels, we have In-School Coordinators (ISCs) to provide support and assistance to students, staff, and administrators. The Special Education Department holds monthly professional learning meetings with new teachers on a variety of topics related to compliance, processes, and procedures. At the district level, we have not been non-compliant in many areas, therefore, the processes in place are deemed effective.
