ELIGIBILITY

The candidate must be at least 18 years of age.

The candidate must meet the residency requirements described below, depending on the office for which you are running.

The candidacy form must be completed and submitted by the deadline indicated.

RESIDENCY

For the indicated open RCA Director Offices, you must live in SMALL TAX DISTRICT 5, be a Reston resident, and vote in designated precincts/polling places of Districts in Reston.

Hunters Woods District Director:

Dogwood, Hunters Woods Precincts

(Polling places Dogwood Elementary or Hunters Woods Elementary)

South Lakes District Director:

Glade, South Lakes, Terraset Precincts

(Polling places South Lakes High School, Hughes Middle School or Reston Community Center at Colts Neck Road)

North Point District Director:

North Point and Aldrin Precincts

(Polling places St. Thomas a Becket Church or Buzz Aldrin Elementary)

Town Center/Lake Anne/Tall Oaks District Director:

Reston I, Reston II, Reston III or Cameron Glen Precincts

(Polling places Forest Edge Elementary or Lake Anne Elementary)

REVIEW OF CANDIDACY FORMS

Upon receipt of all applications by the deadline for submission, the Election Committee will review same to ensure that they are complete and reflect the Reston residency requirement.
