

# ACT<sup>®</sup> Senior ACT Retake- Thurs, October 3<sup>rd</sup>

### I. **Before Test Day**

- Complete MyACT Non-Test Information (pick up from advisory teacher)
- Check Testing Location for Test Day- posted in Canvas
- Check that you have a permitted calculator for use on the math portion of the ACT
  - o The calculator policy can be found at act.org or in the Canvas module (in Class of 2025 grade level course)
- Once the ACT is finished, students will be dismissed and report to their 3<sup>rd</sup> block class. Students who are wanting to check out after the test, should bring a hand-written early dismissal note and give it to their room proctor at the BEGINNING of the test.

### II. On Test Day

- What to bring on test day:
  - o \*\*KCS Chromebook- the ACT is being given online!
  - o Acceptable ID (school ID, driving permit, driver's license, etc.)
  - o Writing Utensils (pen or pencil)
  - o Optional: Permitted Calculator (there is a calculator on the platform)
  - o Optional: Water/Snack for during the break outside of the classroom
- Report to testing location by 8:10 a.m. and check in
- You may not handle or access a cell phone or electronic device (including smart watches) at any time in the test room or during break times.
- All electronic devices must be off and out of sight.
- If students access a device or if the device activates while in a test room or during break times, you will be dismissed, your test will not be scored, and your device may be taken.
- Watches must be removed and placed face up on the desk. During the break, they must remain in the test room, removed from the desk, and put away.

#### III. After the Test

- Students will be dismissed from the testing location once testing has finished AND all secure materials are collected.
- If students wish to dismiss early after the test, they should turn in a hand-written early dismissal note to their ACT proctor. The proctor will then issue a pass for them to leave once they are dismissed from the testing room.
