1. Risk

- I am fully responsible for any risks associated with the use of "THE SPOT" center. I am aware that the extreme sport I have chosen involves a high level of risk. In the event of accidents, injuries, death, or damage to or loss of equipment, or in any other cases, I will not make any claims against "THE SPOT" center employees, other participants, or the administration of "THE SPOT" center.

2. Liability

- I am personally responsible, not the employees, if I cause harm to another person's health or property.
- I understand and agree that I am solely responsible for taking care of my own equipment and its safety.
- I agree to wear a protective helmet if I am under 18 years of age.
- I will act in good faith and behave in a sportsmanlike manner.
- I will not consume alcohol, cigarettes, or other intoxicating substances in "THE SPOT" center or its territory, nor will I be present there under the influence of alcohol or narcotics.

3. Insurance

- I am fully aware of the risks to my life, health, and private property within the territory of "THE SPOT" center.
- I am responsible for obtaining life or health insurance that covers high-risk sports activities.

4. Media and advertising

- I agree that video and photo materials in which I appear, taken within "THE SPOT" center territory, may be published online or in other media, including for advertising purposes.
- I acknowledge that video surveillance is conducted in "THE SPOT" center territory for safety reasons.

5. Data processing

- I hereby confirm that I agree to the processing of my personal data by "THE SPOT" center and to the transfer of such data to companies and persons providing services to "THE SPOT" center, when necessary for the planning, organization, or execution of "THE SPOT" events and activities.
- I am informed that my personal data may be transferred to transport companies, travel agents, event organizers, and other companies, including "THE SPOT" center's partners, supporters, and sponsors.
- I also confirm my consent to the transfer of my personal data for processing for the above-mentioned purposes to data operators outside the European Union, with whom "THE SPOT" center cooperates and/or whose services it uses, ensuring that such data operators comply with data protection standards equivalent to those required by the European Union.
- I also consent to "THE SPOT" center's use of my personal data (including photos and videos featuring me) at its discretion for marketing and public relations purposes — in announcements, publications, presentations, and other materials intended for public display or media use (including social media such as "THE SPOT" website, Facebook, Twitter, Instagram, LinkedIn, etc.) — during and after my participation in sporting activities, for an unlimited period of time.

- I understand that any disputes related to this declaration (including competition, injury, etc.) will be resolved in the courts of the Republic of Latvia in accordance with Latvian law and this agreement.
