The manuscript is typed using Microsoft Word program on A4 size, around 4,500-6,000 words (excluding references) in Garamond size 12 pts, 1.15 space, and 1.5 cm first line indent.

It is an effort of author in applying framework of analysis to verify research findings. It possibly consists of paradigm, approach, models or theoretical basis. It is allowed to use the suitable words to replace the sub-title. Research objective written in the end of introduction. Text written in multiple 1.15 space, 12pt, and 1.5 cm first line indent.

## **Metode/ Methods (12pt, Bold)**

It explains research steps/ procedures consist of object of research, data/ sampling, technique of data collections, and technique of analysis based on certain field of studies that explicitly show how to find research findings. Text written in multiple 1.15 space, 12pt, and 1.5 cm first line indent.

## **Hasil dan Pembahasan/ Result and Discussion (12pt, Bold)**

The author presents arguments containing research findings or results, reinforced with relevant data and information. The sub-section discussions contain variables based on theoretical

framework. It is allowed to use the suitable words to replace the sub-title. Text written in multiple 1.15 space, 12pt, and 1.5 cm first line indent.

The analysis sourced from the interview described in paragraph (paraphrase). i.e. Based on the statement from the villager, most of the farmer in Dusun Jati left their job and went to the city. They argue that living in the municipal area will provide economic well-being (Rukiyat, 2020). If it is necessary to represent the text of speech or important statement for content analysis, the author written the paragraph by followed the example above,

“Theoretical definition or speech by referring to a particular thinkers or prominent leaders written by direct quotations using Garamond letters, size 10, multiple 1,15 space. Paragraph written by 1 cm left indent and right indent format. However, it is recommended if possible described in paragraphs rather than direct quotations. If the sentences less than 4 (four) lines, the sentences written as a part of single paragraph with italic texts” (name, year, p.00)
