ALT-DCM At our last district meeting the subject of printed schedules was briefly discussed. I have been helping with a motion that addresses this. The motion and background material will be handed out tonight so it can be taken back to your groups. There will be no discussion until next month's meeting on 4/6/2023. Then a simple majority will be needed to proceed after which at the May meeting a 2/3rds majority will be needed to pass the guideline change. On February 8th I attended a service workshop put on by our neighboring District 8 in Wisconsin. Steve and Janet were part of the panel and I want to thank District 8 and the Beloit fellowship for all their hard work putting on this informative workshop. Our DCM has emailed all the GSR's the final agenda items for the next Gerneral Service Conference. I wanted to touch briefly on that document. The entire confidential document is 1021 pages (that's an entire ream of double-sided paper if printed), however under the folder link the 02-73 document that is four pages titled General Service Conference Committees Agenda Items our Area 20 delegate Chris D has highlighted and made active links to the more important issues being discussed so we can more easily navigate this document. Just a few of the examples he has pointed out are: Ongoing development of the Big Book 5th edition; Development of a simple language Big Book; Changes and new pamphlets for AA groups literature racks etc...The suggestions and agenda items all come from the groups and their GSR's to be brought up at the General Service Conference on April 23rd through 29th this year. Our delegate Chris fully understands this entire document and needs to know the group's opinions on agenda items through their GSR. I encourage our district GSR's to review and discuss with their groups some of the agenda items that are important to them and to attend and vote at our Area Assembly on March 10th, 2023, and the Pre-General Service Conference on April 1st, 2023. You can attend in person or zoom. Remember that the most important position in AA service (besides your greeter) is the GSR representing a group. Finally, I want to thank the two speakers I heard last month for their service in sharing experience, strength and hope. I was pleased to be able to hear Sheila W. speak on February 4th at SOWANI and our corrections chair Kim S not only did a great job speaking at the Upper Room on February 25th she stood in at the last minute to do this when another speaker could not make it. Please Rember to always support our speakers, they put a lot into doing this service.

DCM: Some of the General Service Conference (G.S.C.)Agenda items will be discussed briefly at the Spring Assembly, March 11th during the Spring Conference. More in depth discussion will be at the NIA20 PRE-GENERAL SERVICE CONFERENCE WORKSHOP (Pre-G.S.C.) on April 1st. These items will be discussed and voted on and input is given to our Area Delegate for the upcoming G.S.C. **Everybody that attends the Pre-G.S.C. Workshop has a vote.** You don't have to be an officer of Area or of a District. It is a consensus vote of our Area's Fellowship for our G.S.C. Rep. More info will be out on the Pre-G.S.C. soon. You can attend in person or on Zoom. I really like the fact that everyone who attends has a vote and can give input. Our 4th concept talks about the Right of Participation. You do get to participate in the G.S.C. No matter what level of service your are at, or just a member of A.A., which put you at the top of the triangle of the structure of the G.S.C. If you are a GSR and you do not attend the Area assemblies and the Pre-G.S.C. Workshop, your group is not connected to AA as a whole.
