

Preschool Enrollment

2025-2026 School Year

Registration for the Integrated Preschool will begin on **February 3, 2025**. To request registration, please email your child's name and Date of Birth and your name to the Preschool Administrative Assistant at [Preschool Admin](#) on or after **February 3, 2025**. Preschool registration is on a first come, first served basis. Requests prior to this date will not be accepted.

All incoming preschool students must be a Braintree resident and 3 years of age by August 31st of the enrollment year. Students must remain Braintree residents for the duration of the school year to maintain their role as a community peer. If a student is found to reside in another town, then they can no longer attend.

Screening sessions are held in April and May to assess the eligibility of community peers. During the screening process, children visit the preschool for approximately 45 minutes to play with a variety of therapists who will observe their language, academic readiness, social interactions, gross and fine motor skills.

TUITION: Preschool program Tuition Fee for 2025-2026 is \$2,207.00 per student

DEPOSIT: When registration is confirmed a \$100 *non-refundable deposit must be submitted to hold the child's seat. The deposit will be applied towards the first payment installment. Payments must be received on or before the due date for a child to attend.

**Our tuition and deposits are non-refundable. If a child should need to leave the program per a parent's request, then the tuition will be forfeited. If payment is not received by the specified dates, then students are not permitted to attend the program until we receive tuition payments.*

Wait List: Our availability for community student placement changes from year to year based upon the ages of our special education students. **Registration does not guarantee a placement in the preschool.**

- Applications received after the allotted placements are filled will be placed on a waiting list.
- No deposit is required at the time of registration.
- If placement becomes available, then you will be contacted.

 - If the parents/guardians own a home in Braintree, they must complete the ['Affidavit of Residency \(Homeowners\)'](#) form
 - If the parents/guardians rent a property in Braintree and can provide a lease, the **LANDLORD** must complete the ['Affidavit of Residency/Landlord Living Agreement'](#) form
 - If the parents/guardians live in a property in Braintree, but do so as tenants-at-will (no lease), or for no payment to the owner of the property, the **OWNER/LESSEE** of the property must complete the ["Affidavit of Residency by Owner/Lessor"](#) form **and** provide a copy of the owner/lessee's lease and utility bill.

 - Provide a copy of child's **current physical record** (must be signed by a MA physician)

- A child is not considered registered and cannot attend school until the nurse is in possession of these documents!***
As per State Law, your child must have all required immunizations, a physical examination, as well as documentation of a low risk TB assessment before the student may enter school. Should you have any questions, please feel free to contact the school nurse.
