Interviews & Table Talks: Friday, January 30, 2026

Catholic Law joins six other area law schools to participate in the **2026 DC/MD/VA Public Service Recruitment Fair**. The fair will be held **virtually** on Friday, January 30, 2026. The fair brings public sector employers together with law students from seven area law schools seeking public service careers through virtual interviews, virtual table talk, and document collect. There is no fee to participate and employers may choose one or more of the fair's recruitment activities as described below.

The fair is hosted by the following schools: American University Washington College of Law; The Catholic University of America Columbus School of Law; George Mason University Antonin Scalia Law School; Howard University School of Law; University of Baltimore School of Law; University of the District of Columbia David A. Clarke School of Law; and University of Maryland Francis King Carey School of Law.

Invitation to Employers

It is with great pleasure that we invite you to participate in the 24th Annual DC/Maryland/Virginia Public Service Recruitment Fair. There is no fee to participate in the fair. We hope you will join us on Friday, January 30, 2026, for this year's virtual event. Last year brought nearly 100 employers and more than 300 students together through virtual interviews, virtual table talk sessions, and document collect to meet and discuss public interest and public sector opportunities in the surrounding area and beyond.

Hosted by seven area law schools, the recruitment fair allows employers to virtually connect with hundreds of law students in one day. Employers may participate through table talks, structured interviews, or both. Employers who are unavailable

on the day of the fair may opt to receive applications to review on their own schedule, through the fair's Document Collect option.

In order to participate in the fair, employers must register through the fair's online registration system, Flo Recruit, and submit the appropriate schedule request. Registration for employers is now open. Employers interested in virtual interviews or document collect, or table talks must register using the unique links above. The deadline to register is December 12, 2025.

Individual Interviews (Virtual)

Employers may register to virtually interview students on January 30, 2026 via this [link](#). Students will bid for interviews in Flo Recruit based on the information provided by each employer in their Flo Recruit Events record. Once bidding closes, employers will be able to view their application packets on Thursday, January 15, 2026 through Flo Recruit. As a courtesy, the fair team may also provide employers with application packets via email the day after packets are released. Employers will have from Thursday, January 15, 2026 through Tuesday, January 20, 2026 to review

and select candidates to interview. Interviews will be conducted virtually on Friday, January 30, 2026. Employers can select full-day or half-day interview sessions (morning session - 9:00am to 12:15pm; afternoon session – 1:30pm to 5:00pm).

Table Talk (Virtual)

Employers may register for Table Talks via this [link](#). Table Talk sessions give employers and students an opportunity to virtually meet and talk informally the day of the fair. Employers who may be on a different hiring schedule may connect with students to share information about their organization and upcoming application period. No pre-scheduled interviews will be held during the table talk period. All class years will be permitted to participate. Employers may participate in Table Talks in addition to conducting formal, virtual interviews. Table Talks will occur in Flo Recruit; more information to follow registration.
