

Finding 1

Finding(s) by: IA. Operative Lukas Thybo

Description:

On the evening of Sunday, an operative of clearance level 3 assigned to the [REDACTED] Investigation, witnessed the murder of [REDACTED] in a brutal stabbing at [REDACTED]. The incident occurred after [REDACTED] was confronted by his superior ([REDACTED]) about him overstepping his jurisdiction, in disagreement the [REDACTED] at hand attempts to kidnap the superior which fails. Visibly frustrated, the [REDACTED] makes the decision to pull out a knife. Not long after the superior is stabbed and killed in the line of duty by his own college.

Meanwhile the other colleges within the radius of the incident do not attempt to hinder the murder attempt occurring in front of them making them liable to (Negligence 2)

There is clear breaches of the (FLC) in this case and [REDACTED] is charged with the following breaches: (Murder 4, Kidnapping 1 x2, Misuse 2, Negligence 1)

Description:

At about 11:00 o'clock on Thursday, Operative Lukas, an agent of clearance level 3, witnessed [REDACTED] Spearheading a group of dancing Site personnel into D-block with loud tango music blaring out, breaching Foundation Legal Codex (public nuisance 1).

[REDACTED] are not permitted within D-block as a whole and by entering, [REDACTED] clearly breached ZJP, and is subsequently liable of the (FLC) violation (Negligence 1). [REDACTED] continued to lead the group of individuals further into D-block, entering the D-block catwalk with some personnel who are strictly forbidden from entering set location without explicit permissions from Supervisors making set personnel liable for the (FLC) violation of (Trespass 1) and [REDACTED] in (FLC) violation of (Negligence 2).

Furthermore [REDACTED] Leaps down to Lower D-block from the catwalk with site personnel, subsequently causing self harm and inciting cause of self harm, violating Foundation Legal Codex (Manslaughter 1).

In this case [REDACTED] is found in violation with following charges:
(Manslaughter 1, public nuisance 1, Negligence 1, Negligence 2)

Description:

Thursday afternoon, Agent Natin, clearance level 3, while conducting investigative work on [REDACTED] witnessed the kidnapping and murder of [REDACTED] by firing line and hanging in the Core sector. The incident occurred when [REDACTED] [REDACTED], and [REDACTED] arrived at the Interrogation entrance, from where the kidnapping took place. [REDACTED] brought the [REDACTED] to Core sector, where he tied up in the restraints to a powerful drone, and raised him off the ground causing excruciating pain to the [REDACTED] from being hanged. Not long after, The [REDACTED] decided to call a firing squad, "Declaring his execution" the accomplices to the crime eagerly cheered on when the order was given [REDACTED] laughing ominously", shortly after [REDACTED] [REDACTED], and [REDACTED] fired until the individual was deceased.

Description:

At about 11:50 on Friday, Operative Lukas Thybo, an agent of clearance level 3 conducting investigative work on [REDACTED] outside personnel bathrooms, bore witness to the killing of fellow [REDACTED] by the hands of [REDACTED] The incident occurred when [REDACTED] asked [REDACTED] [REDACTED] if he was being threatened by set agent. [REDACTED] n responded "yes i am" and within less than one second [REDACTED] had shot and killed set agent.

Bystander and fellow [REDACTED] failed to act upon witnessing the incident unfold, making [REDACTED] liable of (FLC) violation: (Negligence 2, and (Corruption 1 - Nepotism))

It is noted that [REDACTED] attempted to act within self defense, but due to [REDACTED] not showing any physical threat to the life of Special [REDACTED] this can't be ruled in. Rather than attempting an arrest the agent sorted to an instant execution and is there for liable of (FLC) violation: (Manslaughter 1, and Protocol 1)

Finding 5

Description:

At 01:00 o'clock at night on Saturday, Operative Lukas Thybo, an agent of clearance 3, observed while on duty, in site off hours [REDACTED] conducting GENSEC duties and actively engaging D-Class personnel in the process of rioting within D-block violating ZJP making [REDACTED] liable of (FLC) violation: (Negligence 1, Protocol 1, Trespass 1)

It should be mentioned that [REDACTED] insisted on the External affairs agent stay and attempted to kick out Operative Lukas Thybo. The set operative disclosed his reasoning being within confines of D-block airlock. [REDACTED] continued interfering with Operative Lukas Thybo's investigation into the matter of the [REDACTED] reasoning for entering D-block, [REDACTED] in violation of the following Foundation Legal Codexes: (Interference 1, Negligence 2, Protocol 1)

Note: There is clear (FLC) violations in this case calling for further investigations into [REDACTED] in the future.
