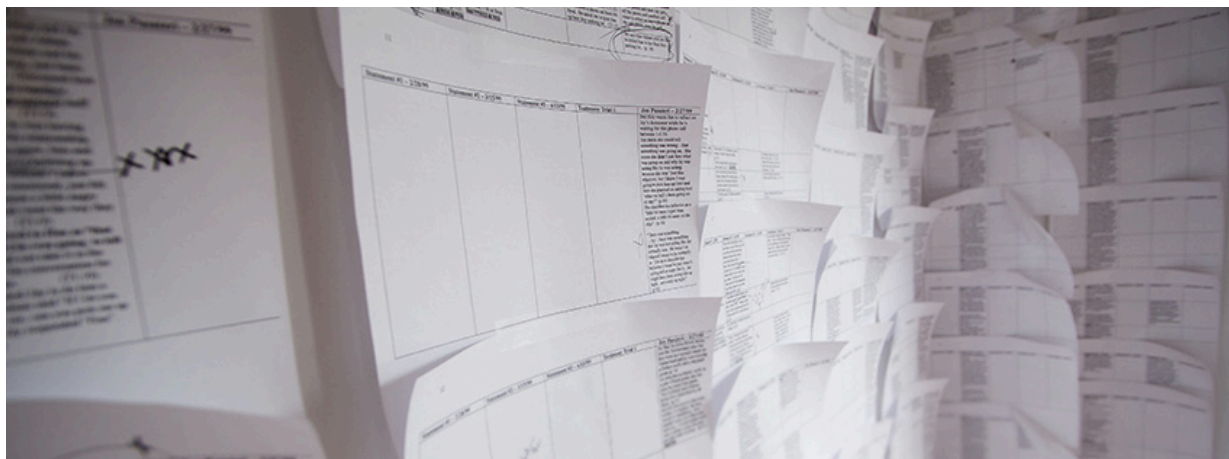
**Warning:** There may be information included or linked to in this document that would be considered a "spoiler", such as information that has not been included in the podcast.

- Senior at Woodlawn High School
  - Magnet Program Student, Honor Roll
  - Member of Lacrosse, Field Hockey, French Club, Ecology Club, SADD
  - Manager of the Wrestling Team
- Daughter of Korean immigrants, had 1 younger brother (Young)
- According to Baltimore Sun, Hae Min Lee did not move to the U.S. until she was a pre-teen.
- Was last seen by Inez at the concession stand after 2:15pm
- Was supposed to pick her cousin up at 3:15pm
- Worked at LensCrafters
- "Aspired to be an optician" [Source: [Baltimore Sun](#)]
- Her boyfriend at the TOD was Don, a co-worker at LensCrafters
- Owned a pager, but no cell phone

1. **Who killed Hae Min Lee?**

That's the million dollar question, isn't it? Adnan Syed was found guilty by a jury of murdering Hae, and is currently serving a life sentence for her murder. But if you've actually listened to the podcast, you'd know that things may not be as they appear. If it were a simple black and white answer, we wouldn't be here.

2. **Could Hae have died accidentally?**

There are theories that range from a heated fight to autoerotic asphyxiation, but it's improbable that she was strangled to death on accident. Whether or not the murder was premeditated vs. a crime of passion is questionable.

2. **Why didn't Hae fight back or honk the horn?**

It's unknown either way whether she did fight back or honk the horn. Hae was 5'8 and an athlete. She may have suffered from head trauma before being strangled, which would make her disoriented. She may have been surprised from behind if someone was in her back seat. Hae's turn signal was broken off [Source: Appellate PDFs], possibly by being kicked off. She may have been trying to fight back or honk the horn.

3. **Did they check Hae's pager logs?**

Unknown. We have heard nothing about her pager or any pager logs. The pager may have been thrown out with other evidence from the car, but this piece of the puzzle is still MIA. Pagers do not ping to towers like cell phones do, so if there are logs, they would most likely only have limited contact info such as the numbers or short codes that were sent to the pager.

4. **Why were Hae's lips blue?**

It happens before death, when oxygen is restricted. [\[Source: Blue Lips\]](#)

5. **Was Hae pregnant?**

No. Hae was not pregnant at the TOD. There are theories on the subreddit that she may have been pregnant months before, but this is only speculation based on the note passed back and forth in class between Adnan and Aisha.

6. **Was Hae sexually assaulted?**

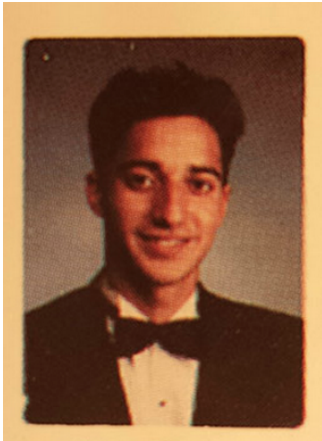
There is no evidence to suggest that she was sexually assaulted that day.

2. **When was Adnan first questioned by police?**

***"[Adnan] was questioned by police on January 25, 1999 about Hae's disappearance. He told the police that he and Hae used to date. He said that on January 13, 1999, a Wednesday, he had class with Hae from 12:50 to 2:15 p.m. [Adnan] said he went to track practice that afternoon. He did not see Hae the next two days at school, Thursday and Friday, because the school was closed for inclement weather. (1/31/00-25)"*** [Source: [Brief of Appellant](#)]

***"On February 26, 1999, after speaking with Jennifer, MacGillivray went to Appellant's home and Appellant gave a statement. Appellant said he had a relationship with Hae, and had been in her car before, but not on January 13, 1999. (2/17/00-264) Appellant said he did not remember what happened on January 13, 1999. (2/17/00-271) A police report of this statement was not written until September 14, 1999. On February 27, 1999, Appellant was questioned at school and at the police station and gave statements denying his involvement."*** [Source: [Brief of Appellant](#)]



3. **Did they check Adnan's email account?**

Unknown. The police did check Hae's email account during the trial, but as far as anyone knows, not Adnan's. Someone/Adnan(?) tried to log into his email account

(Note: Hotmail) years later but by that time, the account had been deactivated (Source: [/u/rabiaanwar](#)). There has been no word on anyone subpoenaing or contacting Microsoft to see if they can retrieve the account information.

1. **How do they know Adnan?** Saad is one of Adnan's best friends. He did not go to Woodlawn HS, but they hung out on weekends. Rabia is Saad's older sister, and the one who brought the case to SK's attention in 2013.

1. **Where is Jay!? Why don't we know Jay's full name?** Jay is alive, free, and now lives in another state with his family. Jay's name has not been included in the podcast for unknown reasons, and is not allowed on this subreddit because of privacy concerns. (*I added "alive" because many people seem to think he is dead?*)
2. **Is he in prison? How long was Jay in jail?** While he was charged as an *accessory to murder after the fact* [Source: *coming*], Jay did not spend any time in jail. [Source: Rabia]
3. **Why doesn't Jay have a car or cell phone since he's a drug dealer?** Cell phones were incredibly expensive at this point compared to beepers. Cars were also expensive. We don't know Jay's financial situation, or how often he got rides/borrowed other people's cars.

- Close Friend of Jay's, Not Adnan. Best friends with "Cathy".
- Was called 6 times on 1/13/1999 by Adnan's phone
- Has a younger brother

1. **Why was Jenn never charged? Tampering with evidence, accessory after the fact, etc.** She transported Jay after the burial and helped him hide his clothes.



**Excellent answer from Reddit:** "If you charge Jen then you lose her testimony at trial - she'd invoke the fifth amendment (which she could have done anyway, but she definitely would invoke if she was charged). Prosecutors have to do a cost benefit analysis: *Do I charge everyone I can, or do I want their testimony at trial against the primary defendant?*" - [/u/Velvet\\_Snickers](#)

1. **Where was Stephanie on the day of the murder?**

The day of Hae's murder was her birthday, and was in school. After school, she had basketball practice [Source: [/u/whtworks](#)]


2. **Where is Stephanie now? Will she be on the podcast?**

Unknown. According to unverified comments [Source: [/u/whtworks](#)] Stephanie has moved on with her life, wants nothing to do with the case, and will not be on the podcast. SK says that Stephanie declined to talk to her [Source: Ep. 8]


3. **Where was Stephanie during the trial?**

*"...funny thing is, for her and Adnan being "best friends" **she was MIA during the trial and was not really investigated.** I would actually love to hear her side of the story, she dropped Adnan like a bad habit when he got locked up."* - Saad [\[Source: AMA\]](#)

**"Hae's body was found in Leakin Park on February 9, 1999 by a man named ["Mr. S."].** (1/31/00'-27) He testified that he saw the body in Leakin Park when he went to find a private spot to urinate. Unbeknownst to the jury, ["Mr. S."] had been previously convicted of indecent exposure. ["Mr. S."] testified that he left his house and was driving to work when he had to pull his car over to urinate in the park. The park was only a few blocks away from his house. (2/23/00-9) **The body was 127 feet from the road and was difficult to see.** (1/31/00-101) The body was not even visible to Dr. Rodriguez, a member of the recovery team who went to exhume the body. (1/28/00-182) Dr. Rodriguez testified that the body was well hidden, and the average person would not be able to see it. (1/28/00-182)" - [Source: [Brief of Appellant](#)]

"[Cathy] testified as follows. On January 13, 1999, at 5:00-5:15 p.m., she arrived home, and her boyfriend Jeff was there. **[Jay] and [Adnan] arrived later, and were acting "shady."** (2/16/00-217) **She had never met [Adnan] before.** They all watched television at about 6:00 p.m. [Adnan] was lying on some pillows on her floor when he asked, "How do you get rid of a high?" (2/16/00-210) [Adnan] got a call on his cell phone and said, "they're going to come and talk to me, what should I say, what should I do?" (2/16/00-213) Then [Adnan] and [Jay] left. (2/16/00-214) [Jay] returned hours later with Jennifer, but [Adnan] was not with them." [Source: [Brief of Appellant](#)]

### 1. What do we know about Yasser Ali?

- Feb 12, 1999 - Two anonymous calls with an "Asian" accent were made to police that lead them to interview Yasser Ali
- Feb 15, 1999 - Police speak to Yasser Ali
- Feb 16, 1999 - Police subpoena Adnan's cellphone records

**From the podcast:** ". . . The caller remembered about a year ago, the suspect [Adnan] informed a friend of his (Basir [sic] Ali, Asian male, 17) if he ever hurt his girlfriend, he would drive her car into a lake."

"Yasser Ali is a part of the Pakistani community and he was friends with Adnan. I don't think Yasser and Jay knew each other but I don't know for sure. I am not friends with Yasser Ali, he went to a different high school then Adnan and I had went to." - Saad, [\[Source: AMA\]](#)

## The Relationships

### 1. Why did Adnan give Jay his phone and let him borrow his car?

**Adnan's Story:** On that specific day, Adnan says he lent Jay his phone and car so that Jay could buy his girlfriend, Stephanie, a birthday gift. Adnan did not need the car because he was in school that day. [Source: *Serial*, Ep 1 or 2]

**Jay's Story:** According to the 1999 tapes, Jay says that Adnan lent him the car so that Jay could pick him up later after Adnan killed Hae. [Source: *Serial*, Ep 1 or 2]

**Opinion from teens in 1999:** As far as "Why would you lend someone your cell phone/car" in the general sense, Adnan often lent his car, and his phone, out to friends. This was not strange amongst teenagers of that generation:

*I was also in high school and driving in 1999. I had a cell phone as well, but it was only for driving (in case I got in an accident or needed to call AAA). My school had an explicit ban on all electronics on campus (I got detention for listening to my discman during my free period, jerks!). This was before Columbine (which, remember, was April 1999), which is when the debates about whether schools should allow cellphones on campus really started.*

*Adnan likely had no use for the phone during the school day, and, without his car, had no where to stash it during the day. Plus, Jay may not have had a phone and Adnan might have thought it necessary to use to track Jay down after school..Just my two cents, but I think we need to remember that in 1999 we were no where near as attached to our phones as we are now and they were no where near as ubiquitous. Heck, my cell phone was off most of the time.*

### 2. Why won't Adnan accuse Jay of killing Hae or why isn't he more angry with Jay? Why haven't we heard Adnan say "I'm Innocent" yet?

First off, we don't know for a fact what Adnan's theories are about what happened. Adnan's priority is not to find out who killed Hae, but to prove his innocence. (1) What point is there in blaming Jay when Adnan says he doesn't know what happened to her that day? It only makes Adnan look bad to throw stones without proof. As far as being angry, **we don't know how he felt then or now, 15 years later**. We have only heard a very small percentage of his phone calls with SK.

Saad said that Adnan doesn't want to point fingers, and that Adnan's family safety might also be a concern. [Source: /u/Sdotchaudry, Saad's "[AMA](#)"]

### 3. If it was Stephanie's birthday, why didn't Jay/Adnan call/hang out with her that day?

Jen and Jay said that Jay (and maybe Jen?) did see Stephanie later that night (below), but what they did has not been explored. Adnan wouldn't necessarily need to call Stephanie, he already gave his gift to her when he saw her that morning [Source: Episode 1 or 2]. As stated earlier, Stephanie was in school all day and [unverified] had basketball practice after school. We don't know if Stephanie had a cell phone or pager, or what she says about that day.

#### - From Episode 4:

*Sarah Koenig: Jenn tells them she drives Jay back to Westview Mall to the dumpsters back there so that Jay can retrieve the shovels and wipe the handles clean in case of fingerprints.*

*Jennifer Pusateri: After that, Jay came back, got in my car, and he was really shaken up. He was completely shaken up. He was like you have to take me to go see my girlfriend now.*

#### - From the appeal document:

*"Jennifer testified [Jay] told her he wanted to go check on Stephanie to make sure she was okay. They went to Stephanie's house between 8:30-9:00 p.m."*

### 4. Were Jay and Jenn secretly sleeping together?

Unknown. There are rumors that they were more than just friends. Hae was [allegedly] going to confront Jay about cheating on Stephanie. [Source: Saad/Rabia comments on reddit, link coming].

### 5. Whose dad is the detective in another county?

"Cathy", Jenn's friend. (Source: EP04 @ 25:00) "The next time he tells it, he says that when that call comes, they're at a friend's apartment – a friend whose father happens to be a homicide detective in another county. Jay tells the cops he'd actually been to her house three different times that day, but he didn't want to get her in trouble." This must be "Cathy" from

EP06. "Cathy" is Jenn's friend. (Source: EP06 @ 13:12)

**6. What was the relationship between Hae & Jay? Was Jay Hae's drug dealer?**

- It is unknown whether or not Hae got her drugs from Jay.
- "Hae didn't 'trust' or really like Jay but she was cordial with him bc he was Steph's BF" - Saad [\[Source: AMA\]](#)

**7. Were Jay and Adnan friends after the murder until Jay talked to the police?**

Yes, or at least, they were still hanging out. Adnan puts Jay on the phone to say 'Hi' to Nisha in the weeks after the murder. Jay was working at the video store during that call, a job he didn't have until late January [Source: Serial, Ep 06].

**8. Was Jay jealous of Adnan and Stephanie's close friendship?**

**According to Jay, No:** "Even though Appellant was the prom king [sic] and Stephanie was the prom queen [sic], [Jay] said he was not jealous of Appellant's relationship with Stephanie. (2/14/00-66)" [Source: [Brief of Appellant](#)]

**9. Jay and Jenn are still friends on Facebook! Isn't that suspicious!?**

Lets be real here - A friend who will help you wipe fingerprints and dump evidence for a murder they weren't involved in is a friend for life.

**10. Why didn't Adnan try to contact Hae?**

**9. Were Jay and Adnan really friends?**

- "[Jay] said Appellant was an acquaintance of his, and he gave [Jay] a ride in his car one time."

**10. Was Adnan heartbroken? Was he really over Hae?**

This is a very debatable point. Adnan **was** actively dating/sleeping with many other girls (e.g. Nisha, Anjali, another girl at Woodlawn, etc) during the time of Hae's disappearance. Hae and Adnan had been on-and-off again (multiple break-ups), as recently as the Fall of their Senior Year. Adnan even helped Hae fix her car when it broke down at Lenscrafters, and showed no hostility towards Don when he met him:

*"Don [redacted] testified that he dated Hae after she and Appellant broke up, from January 1, 1999 until her disappearance on January 13, 1999. (2/1/00-71) On one occasion between January 1 and 13, he saw Appellant at the Lens Crafter store where both Don and Hae worked. Appellant came out to the store to inspect Hae's car because it was not running properly. Both Don and Appellant concluded that the car was not safe for Hae to drive home. **Don said that Appellant, who knew Hae and Don were dating, was not hostile to him.** Appellant drove Hae home that*



night.” [Source: [Brief of Appellant](#)]

Hae’s diary and letters to Adnan give the impression that he was still trying to win her back, but all of this is very he-said-she-said, and we all know how teenagers can be. [Source coming with Hae’s diary]

**According to Adnan:** No, Adnan was not heartbroken, he had moved on and had no bad feelings for Hae. [Source: Podcast Interviews, Adnan’s friends]

**According to Saad, who knew Adnan was sleeping and dating with other girls:** *“We will be hearing about Adnan’s attorney during that time, but I had offered her proof that Adnan wasn’t devastated by Hae dating another guy, I actually gave his attorney names and numbers of girls Adnan had started dating and sleeping with. She did not follow up with any of those girls, she brushed it under the rug and said “they have no evidence, the burden of proof is on them” - Saad* [Source: [AMA](#)]

**From [Brief of Appellant](#):** *“Friends testified that both Hae and Appellant were sad about the breakup, but not bitter or angry. (1/28/00-224)”*

**From Inez [Source: [Brief of Appellant](#)]:** *“Inez Butler Hendricks testified that after Hae’s body was found, Appellant told her that his last memories of Hae were not good, that they had a fight about Hae going to the prom with Appellant. (2/4/00-26)”*

**From Yaser [Source: [Brief of Appellant](#)]:** *“Yaser Ali, Appellant’s best friend, testified that Appellant told him that the relationship was over because it was too hard to hide it from his family, and that the breakup was a mutual decision. (2/3/00-88) Ali also testified that Appellant wanted to remain friends with Hae after the break up, and that Appellant had interests in other girls as of December, 1998. (2/3/00-117-123)”*

**From Hae’s friend Debbie Warren [Source: [Brief of Appellant](#)]:** *“Debbie Warren testified as follows. She was a close friend of Hae’s. **[Adnan] and Hae were boyfriend and girlfriend, but broke up and got back together two or three times.** She said that the last time they broke up because Hae felt that [Adnan] was being **overprotective** of her. Hae began to date “Donnie” and [Adnan] knew about it. [Adnan] told Debbie he thought Hae and Donnie were having sex while [Adnan] and Hae were still dating, but Debbie told [Adnan] that it was not true. (2/16/00-298-302)*

*The last time Debbie saw Hae on January 13 was in gym class, and Hae was happy and rushing to go somewhere at 3:00 p.m. Debbie could not remember where Hae was going, but she told police on January 28, 1999 that Hae said she was going to the mall with Don. (2/16/00-306, 2/17/00-70)*

*On cross-examination, Debbie stated that she was friends with Stephanie, and **Stephanie confided to Debbie that she was interested in Appellant.** At the prom in 1998, when [Adnan] was voted prom king [sic] and Stephanie was prom queen [sic], they danced. [Adnan], however, left Stephanie during the dance and went to get Hae to finish the dance with him. (2/17/00-30\_34)*

*Hae broke up with [Adnan] two or three times because she did not want [Adnan] to have to*

*choose between her and his religion, and Hae's parents did not want her to date [Adnan] either. (2/17/00-48)*

*[Adnan] was not mad when Hae broke up with him on these occasions. In fact, even after the final breakup in December 1998, Hae and [Adnan] exchanged holiday gifts. (2/17/00-57) When [Adnan] found out Hae was dating Don, he said he accepted it and would try to move on. (2/17/00-59)"*

**From Rebecca Walker, a friend of Adnan and Hae [Source: [Brief of Appellant](#)]:** "[Adnan] called Rebecca Walker, a close friend of both [Adnan] and Hae, who testified that even after [Adnan] and Hae broke up, they still cared for each other and were still friends. (2/23/00-142) She also testified that [Adnan] was not possessive about Hae, and he was extremely upset by her disappearance. (2/23/00-160, 175)"

*Inez Butler Hendricks, a teacher and athletic trainer at Woodlawn High School and Hae's friend, testified that she saw Hae at 2:15-2:30 p.m. on January 13. Hae told her she was in a hurry to pick up her cousin from school, but that it was not far and she would be back soon.*  
*Hendricks told her to hurry because Hae had to be back by 5:00 p.m. to ride the wrestling team bus to an away match for which Hae was to keep score. (2/4/00-9-20) When Hae did not return by 5:00 p.m., Hendricks took Hae's place as scorer. (2/4/00-21) "* [Source: [Brief of Appellant](#)]
2. What about the charge on Hae's credit card on the day she went missing?  
Hae's bank statements show that there was a charge of \$1.71 made on 1/13/1999. Without a timestamp, this charge could range from earlier around midnight after leaving Don's house, or any time after school.

### 2. What is the likelihood of Adnan being a sociopath/psychopath?

Pretty unlikely. Good insights from [/u/Czanne](#):

*In 6 years of clinical practice and 9 years of research practice, I've had around 2-3% sociopaths/Anti-social Personality Disorder dx. (My six years were all public mental health, 90% court ordered as a term of probation/parole.) Charming ones? Three or four. Most are, to use the vernacular term of art, assholes. (And six or seven who were convinced they were charming, but weren't. Dunning Kreuger is alive and well.)*

*Charmers are narcissists. They're more prevalent -- 3-5% -- but less likely to be violent, and critically, a lot of teenagers, just as a function of that specific developmental stage, are somewhere on the low end of the narcissistic scale. (Most grow out of it by 20 or so.)*

[Answer: discussion from people who worked in prison populations, no history makes him pretty unlikely to be sociopath or psychopath]

Handwritten notes probably would have been memorialized in police reports and handed over, but the original notes likely would not have.

3. **Does Sarah think Adnan did it?** *SK, Sarah Koenig*

SK has been clear about not taking definitive sides. As a journalist it's her job to stay neutral and objective. Opinion: It's obvious that she enjoys talking to Adnan, but during the times she talks about her feelings, she is very honest that she (and the other people working on Serial) go back and forth often.

4. **Why can't that girl pronounce "MailChimp"?** *MailKimp, Mail Kimp*

The show is mostly about Adnan's side, but Hae's side is so intertwined that it has to be told as well. When it comes to the fact that an innocent man might be in prison, that trumps the privacy of the victim because that means he is a second victim who is currently suffering."
