I reserve the right to decline services without giving reason. By ordering the commission, commissioner(s) agree to the following ToS:

Payment

Prices are shown in (USD) (United States Dollar)

Payment must be received by Paypal invoice only. The invoice will be sent to the provided email address before work begins. Failure to pay the invoice within four days may result in the commission being canceled. Payment must be received before I can put you in queue.

Character Design Commissions

If you do not have a ref for the character(s) being drawn there may be a 10-30\$ USD fee because of the extra work I would have to do to make the artwork.

Complex Character Designs

If the character(s) being drawn are complex, there may be a 10-20\$ USD fee because of the extra work I would have to do to make the artwork.

Confirmation

A WIP sketch for approval can be asked for by the commissioner(s) but this may slow down production.

Incomplete Commission Information

Please provide complete information about the commission, I will ask for more info if it is lacking and this will slow down production.

Completion

Unless I say via journal or note on furaffinty or any other way of contact that there will be a slowdown in completing the commission(s). I have no deadlines and it can take months to get to your commission but a deadline can be discussed in advance and may require extra charge depending on how soon you want it done.

Commissions and Posting

By commissioning me you agree that you are 18+ in age and are of sound body and mind when doing so.

Upon completion of the commission, anyone can re-post the low resolution watermarked art image to any relevant website so long as I am credited for the art. Linking back to my account is appreciated.

The high res image is only for your personal use by the commissioner (such as PC backgrounds and account icons) and as patreon content, please try not to upload anywhere. If you use any of my art as an icon on a site or program, if you can please credit me for the art.

Commissions Corrections

If the commissioner(s) have approved the final piece, no edits will be awarded. References must be accurate as I will follow that reference, no edits will be given because your reference is not clear.

I need at least one coloured image to draw your character unless I am designing/making a reference sheet.

Maximum of one free small edit. If the commissioner(s) have very clearly stated what was required in the original order but I have made a mistake, then I will correct it for free.
