Resolution text

Section 1.

WHEREAS, The Central Student Government Assembly finds and declares all of the following:

Per the Central Student Government Constitution, CSG is supposed to "foster fellowship and collaboration among the students";

There is currently a lack of central, University-wide social events, making it difficult for students to meet other members of the campus not through student orgs, which often have high time commitment;

Central Student Government is a University-wide organization that can help to bring together students and put on events for the entire student body;

There currently exists a lack of visibility of CSG or interest in our proceedings, and hosting events that the student body would be excited to attend would both serve its constituents and ameliorate that issue;

At many other colleges and universities², student governments have a body within them tasked with putting on social and entertainment events, like concerts, dances, bingo-nights, etc;

Other student governments at the University of Michigan-Ann Arbor³, have a body within them tasked with putting on social and entertainment events, like concerts, dances, bingo-nights, etc;

The 9th CSG Assembly passed <u>9-019</u>: A <u>Directive Resolution to Create a CSG Programming Board</u>, which did work to put on a theatrical performance, an ice skating event at Yost Arena, a self defense class, and finals care baskets, all for the betterment of the student body⁵, and although these events fell through due to the global pandemic, there has been some demonstrated interest for the Programming Board to continue past the 9th Assembly.⁶

Section 2.

THEREFORE, the Students of the University of Michigan, through Central Student Government, do enact as follows:

RESOLVED,

That a Programming Board Task Force is authorized for the 10th Assembly, to be run according to Appendix A;

RESOLVED,

that a Project Account titled "Programming Board" is created and, if reauthorized, should be allocated the lesser of \$4,000 or 1% of revenue in the Fall and Winter semester budgets.

Appendix A.

The Programming Board (PB) puts on or directly sponsors social and entertainment events for the student body in order to foster student expression, fellowship, and enrichment of student lives. The PB is made up of five members, including three from the student body not otherwise affiliated with CSG, and including one member chosen from and by the Communications Committee and one member elected from and by the Assembly The PB is run by a Chair, chosen from and by the CSG members of the PB. PB events must be open to all students of the University. The PB must operate at least one event per semester. Any event must be approved by the Comms Chair. These events could be, but not must be, such events as a Formal Dance, finals snack event, a dramatic performance, a concert from a famous artist, etc. For every event, the PB must survey all students who attended the event, at a minimum asking these students "If they enjoyed the event" and "if they would attend the event again", and must transmit this data to the Assembly.
