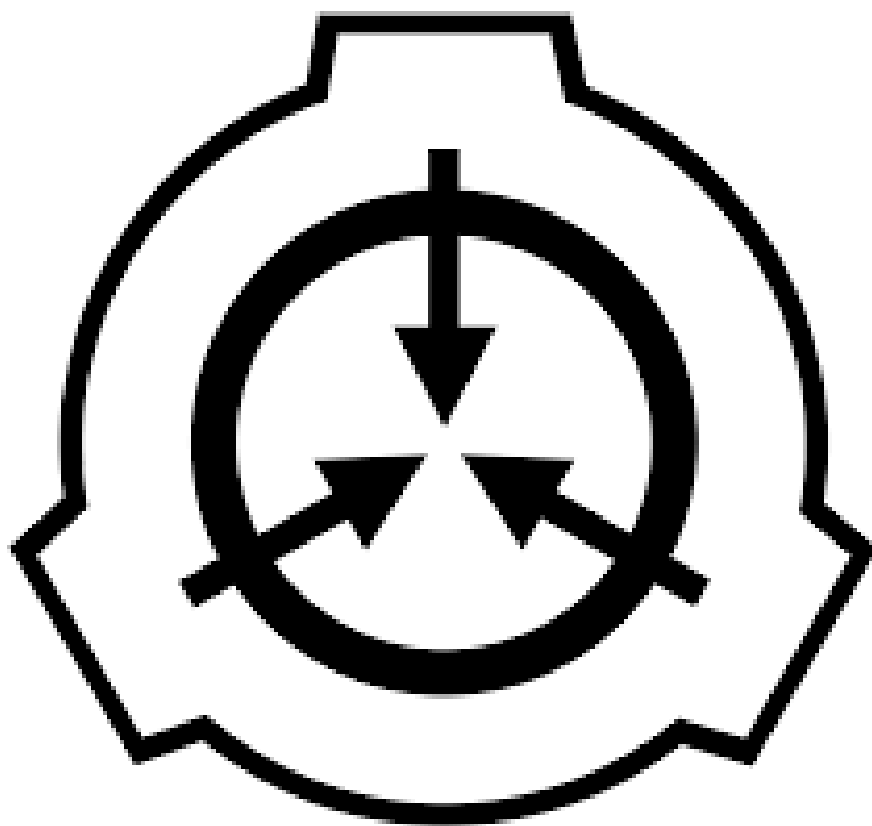

[BACKGROUND INFORMATION]

Teegun was born in a city called [REDACTED] in the Czech Republic. After completing medical school, he achieved success as a doctor, eventually reaching the position of Senior Consultant. Upon obtaining this position, his exceptional performance caught the attention of a field agent. After that, Teegun's file was forwarded to the DoM [REDACTED]. Soon after, Teegun was fired for the following reason of negligence. Unknown to him, this information had been fabricated by our field agent. After he was fired, Teegun received a letter along with a briefcase containing \$10,000. The letter offered him an incredible opportunity to join the medical team at Pinewood Military in Canada. After a year of being a consultant, one of the DoMs, directly the one that did his interview, died in a tragic accident. A gas leak while he was chatting with [REDACTED] at floor 3. He then headed to SDs office and was promoted to the new DoM. After serving as the DoM for 68 days, Teegun began to feel overwhelmed and bored with the position. He requested a job reassignment to Internal Affairs. The Site Manager and Director of Internal Affairs had no complaints and accepted this request. Teegun was given the role of an Internal Affairs Operative. After 15 days in this role, Teegun made another job reassignment request, this time to become an Ambassador. This request was accepted. After this, Teegun was an ambassador for 2 months. He once again made a job reassignment, this time for an ECA. Teegun is currently an Assistant.
