

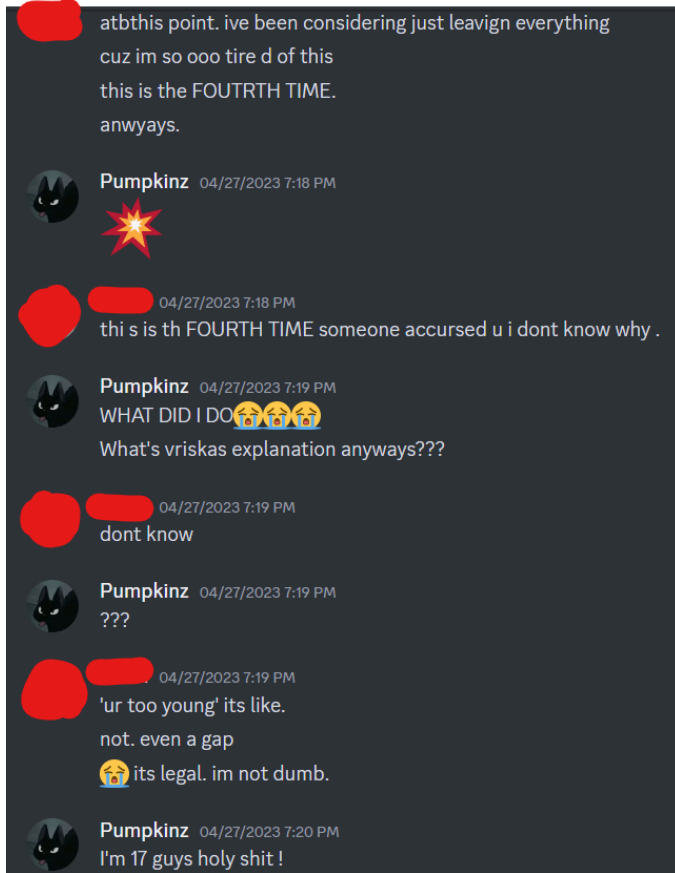
**Massive TW to everyone who reads this. There will be mentions of grooming, rape, pedophilia, and suicide.**

**If you feel you are not capable of stomaching these topics, do not read this document. If needed, reach out to either of the accounts mentioned at the bottom for clarification on the situation.**

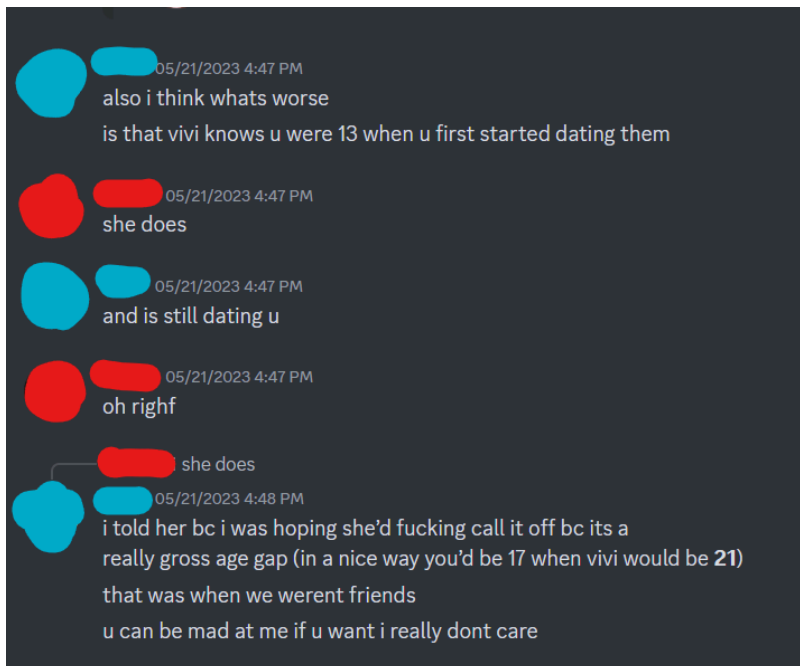
Lucien Hattem, or as some refer to as “Vivi” or “Vividgraves” has undeniably engaged in illegal activity; grooming. They currently are going by “HAVOC” and go under the name “sacrificialgrounds”. For the sake of the document, We will be using their legal name. **Do not refer to them as Lucien outside of this, though. It is their DEADNAME, and the only reason we have used it is because this was originally going to be going to her legal guardians. We’re currently working on that.**

All images were taken over the span of a 9-month “relationship” with Lucien and a minor. Lucien was 16-17 in these, and the child was 13. Names of the child and anyone related in the situation are blurred for their own safety and comfortability. Victim’s name is in red, while bystanders are other colors. Lucien’s name is unblurred.

Lucien would often support the idea of the entire relationship being “legal” when in reality it is not. There were four accusations against Lucien leading up to their eventual split, in which Lucien would continuously defend herself and the relationship and preach it was not illegal. Due to the minor having a lot of trust in Lucien, she would completely support this because she believed this was true. Lucien goes out of their way to defend an illegal relationship.



Lucien also willingly allowed themself to date a 13 year old while knowing the age gap. Even her friends insisted on calling it off due to the illegality of the entire thing, but Lucien continued. Lucien did not care about morality.

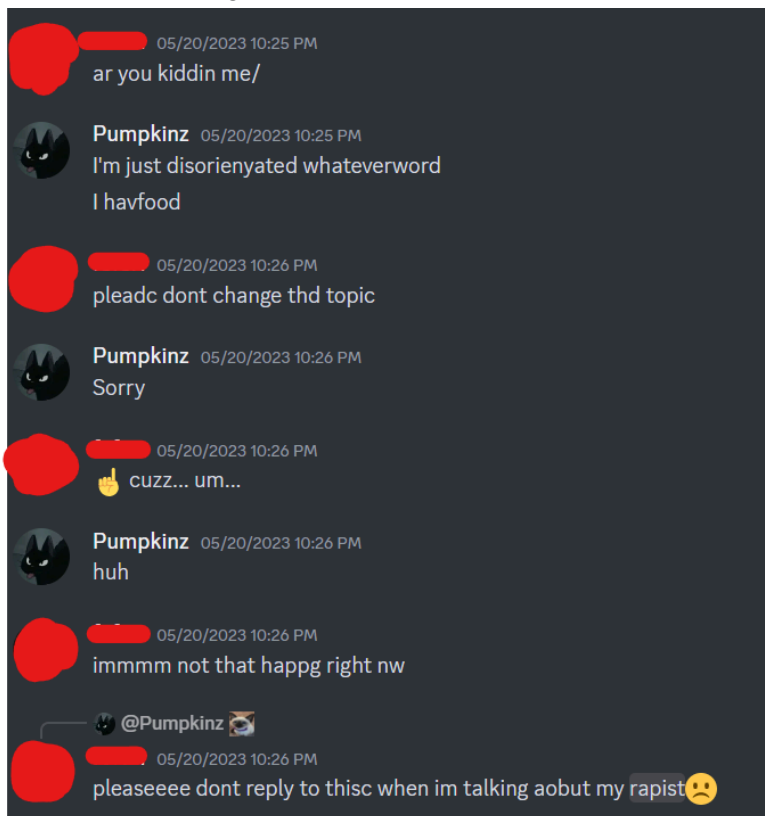

The definition of said law mentioned. Their relationship does not fall under this, as Lucien would be a legal adult in a year while the child could not even drive yet.

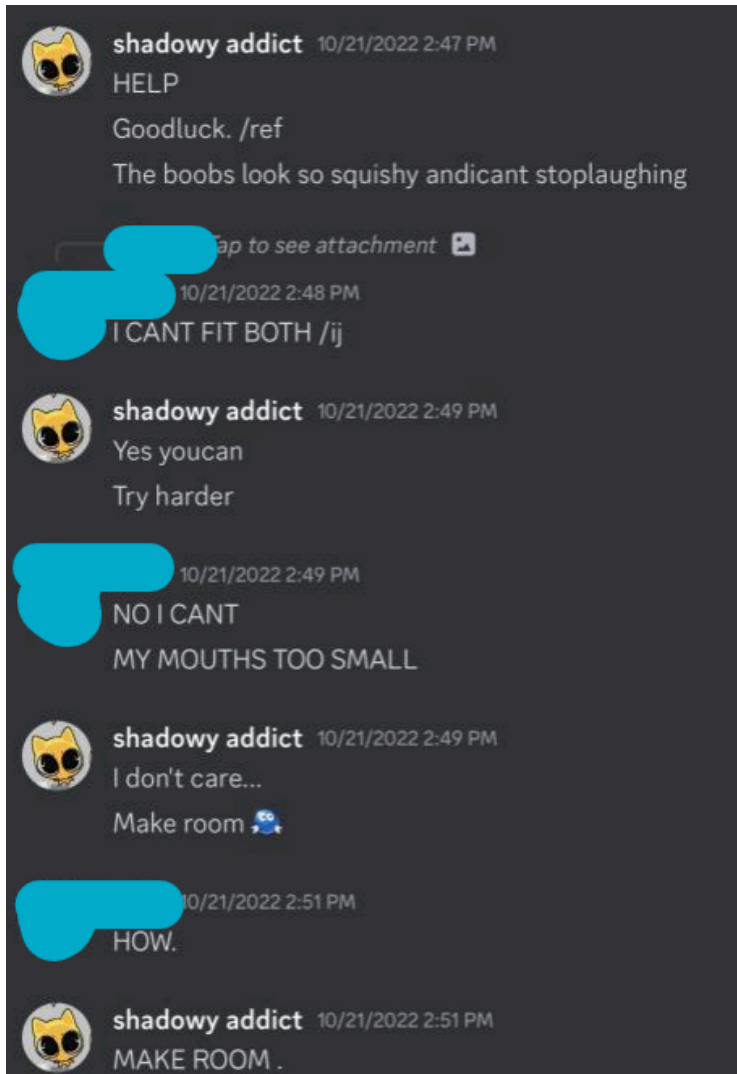
"A Romeo and Juliet law is a type of regulation that exists in some US states to protect young couples below the age of consent from being charged with sexual assault violations, as long as their difference in age is minor and falls into the state-specified guidelines. These laws address situations in which two individuals who are close in age, and one of whom is not yet of legal age, engage in consensual sexual relations. Romeo and Juliet laws provide some leeway around age of consent legislation."

Lucien consistently expresses absent-minded ways and will often try to joke in serious topics, one example being rape.

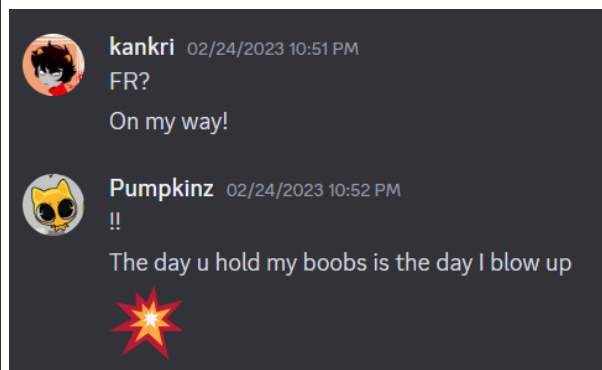
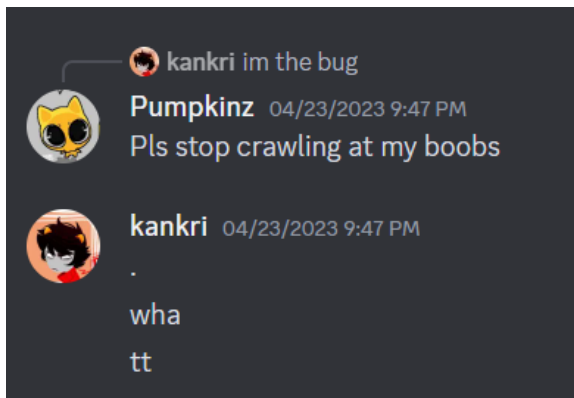


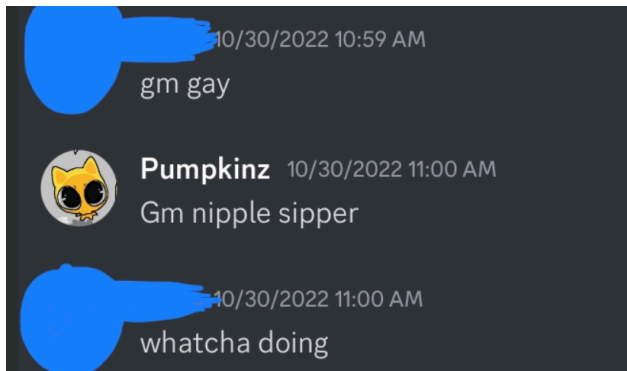
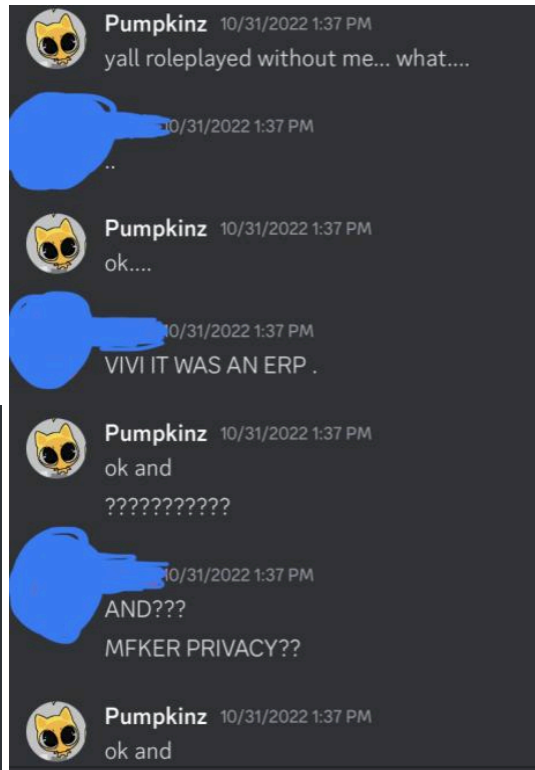
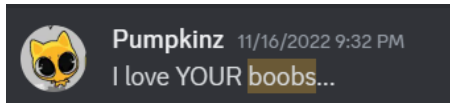
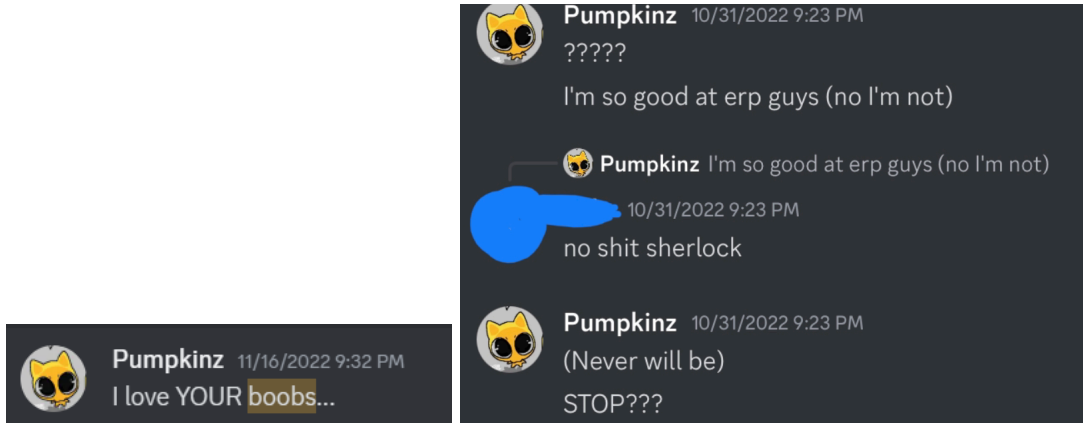
Even past her victim, Lucien consistently would make sexual comments to people, one example being a **14 year old**. This was actively against the minor's boundaries and Lucien continuously

would break those boundaries.

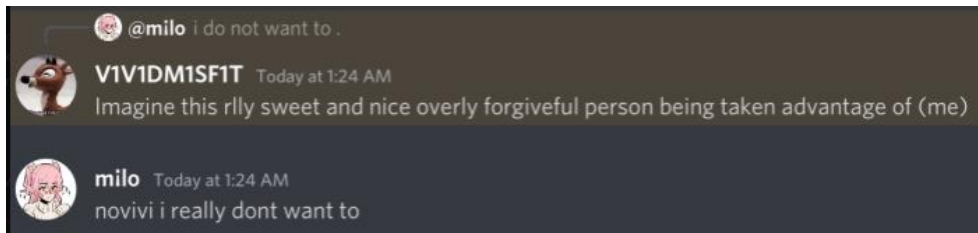


She would continuously make sexual comments to younger people, or just sexualize people in general.

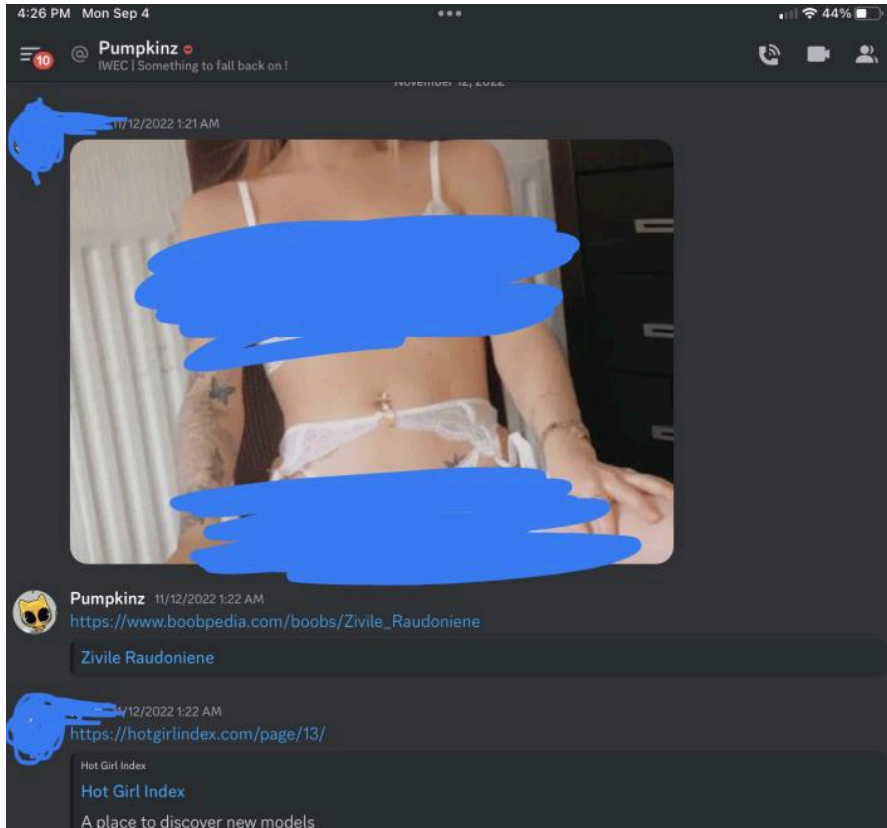




She would consistently victimize herself.
